Preliminary Soils Report
Pursuant to <u>Sacramento City Code Section 17.828.040.C.3</u> , a preliminary soil investigation and geological reconnaissance report by a registered civil engineer specializing and recognized in soil mechanics and foundation engineering is required for every subdivision. If the Public Works Department knows the soil conditions of the proposed subdivision, this requirement may be waived. I requested, waivers must be approved by obtaining the Director of Public Works or designee's signature prior to tentative map application submittal.
Preparation and Form of Tentative Map
Pursuant to <u>Sacramento City Code Section 17.828.050.B</u> , the Director of Public Works may waive the requirements that the tentative map be prepared by a registered civil engineer or licensed land surveyor if the tentative map is clearly and legibly drawn, drawn to scale, and satisfies the requirements of Sacramento City Code Sections 17.828.050 and 17.828.060. If requested, waivers must be approved by obtaining the Director of Public Works or designee's signature prior to tentative map application submittal.
I, the undersigned, being the (acting on behalf of) Development Engineering, do hereby waive the following requirements relating to tentative map applications:
The requirement of Section 17.828.040.C.3 that a preliminary Soil Investigation and Geological Reconnaissance Report to be filed with the tentative map application.
The requirement of Section 17.828.050.A that the tentative map be prepared by a registered civil engineer or licensed land surveyor.

Preliminary Grading Plan: Waiver Requests
Pursuant to Sacramento City Code Section 17.828.040.C.4 submission of a preliminary grading plan is required with tentative map applications. The Utilities Department will consider waivers for this requirement when a preliminary grading plan is not required for proper grading, flood hazard mitigation, and erosion control. If requested, waivers must be approved prior to the tentative map application submittal.
Contour Line Requirements
Pursuant to <u>Sacramento City Code Section 17.828.060.G</u> tentative maps shall include contour lines at intervals of not more than one foot unless waived prior to application submission by the Director of Utilities. If requested, waivers must be approved prior to the tentative map application submittal.
I, the undersigned, being the (acting on behalf of) Utilities Department, do hereby waive the following requirements relating to tentative map applications:
The requirement of Section 17.828.040.C.4 that a preliminary grading plan be filed with the tentative map application.
The requirement of Section 17.828.060.G that the tentative map contain contour lines not more than one foot.
