Applications are processed in the order received. Funding is limited, therefore, rebates are not guaranteed.

An application and inspection is required <u>BEFORE</u> you remove your pre-1992 toilet to verify it qualifies for this rebate. Call 916-808-5605 to schedule an inspection.

To be eligible, you must:

- Be receiving City of Sacramento water service at the property;
- 2. Be the property owner or bill-paying tenant with written consent from the property owner.

Rebate amounts:

- Maximum rebate amount for single-family/duplex customers is \$125 per high efficiency toilet.
- Maximum rebate amount for commercial/multifamily/government/institutional/industrial customers is \$150 per commercial gravity style toilet and \$250 per commercial flushometer type toilet.
- Total rebate amount will not exceed money spent by the customer.
- Eligible expenses include tank, bowl and tax. For commercial installation, the tank (when applicable), bowl and flushometer must be replaced.
- Installation and items needed for installation are not eligible expenses.

Steps to proceed:

- Submit a completed application with pictures of your pre-1992 toilet(s) and gallons per flush (GPF) information*. Pre-1992 toilet(s) must use 3.5 gallons or more per flush to be eligible.
- 2. Schedule a free pre-inspection with Water Conservation staff by calling 916-808-5605.
- 3. Receive approval from Water Conservation staff.
- 4. Purchase and install the new high efficiency toilet(s). You may install the toilet(s) yourself or hire a plumber.
- Submit receipts/invoices and photos of your newlyinstalled toilet(s). Receipts/invoices must include price, model and brand of each toilet listed individually.
- 6. The City of Sacramento will issue rebate checks within 90 days of receipt of your completed application materials. The City is required to send IRS form 1099 to the customer and the IRS when rebates total \$600 or more in a calendar year.

High efficiency toilet (HET) requirements:

- Must use 1.28 gallons or less per flush. Dual flush toilets that average 1.28 gallons or less between two flushing options may also qualify (e.g., a dual flush toilet with 1.6 gallons per flush/0.8 gallons per flush options).
- Replacement of an ultra-low-flush toilet (toilet purchased between 1992 and 2013 that flushes 1.6 gallons per flush) with a HET is not eligible under this program; neither is replacement of a HET with another HET.

NOTE: Building permits are not required when a residential customer simply removes and installs a toilet on existing plumbing. A permit is required when a plumbing fixture will be relocated or you are a commercial customer.

The City of Sacramento, RWA and SacSewer cannot guarantee that the installation of the HET's will result in lower water utility costs. The number of rebates is dependent upon the availability of program funds. Applications will be processed when all required information is provided by the applicant; on a first-come, first-served basis.

^{*}The manufacturer's name and a GPF label often appear right behind the seat hinge on the bowl. If you don't see a GPF label, lift the tank lid and check the inside back of the toilet tank for the manufacturer's date stamp—it is usually stamped directly into the porcelain.
