<b>Section Five: Exemption Requirements</b>	
<b>General</b> (SCC 3.08.030(A)) <i>(Proof of Exemption Required)</i>	Business operations taxes imposed by this chapter do not apply to a person transacting and carrying on a business exempted by the constitution or statute of the United States or of the state of California from the payment of the tax prescribed.
<b>Charitable or Non-Profit Organization</b> (SCC 3.08.030(B)) <i>(Proof of IRS or FTB Exemption Required)</i>	<p>1. Business conducted by a charitable, nonprofit or eleemosynary corporation, association or organization if the net proceeds of said business are used exclusively by such corporation, association or organization for a purpose which would qualify as a charitable deduction under Section 17214 of the <a href="#">Revenue and Taxation Code</a> of the State of California if said net proceeds were received as a gift by said organization.</p> <p>2. The conduct of entertainment, concert, exhibition or lecture on scientific, historical, literary, religious or moral subject, whenever the receipts are for a religious, educational or charitable purpose.</p> <p>3. The conduct of entertainment, dance, concert, exhibition or lecture by a religious, charitable, fraternal, educational, amateur theatrical group, military, state, county or municipal organization or association, whenever the receipts are for the purpose and objects for which the organization or association is formed, and from which profit is not derived, directly or indirectly, by any individual.</p>
<b>Disabled Veteran</b> (SCC 3.08.030(C)) <i>(Proof of Honorable Discharge and Disability Required)</i>	A disabled veteran holding an honorable discharge from a branch of the military service of the United States is exempt from the payment of the business operations tax prescribed by this chapter, if such person is physically unable to earn a livelihood by other means.
<b>Permit Requirements</b> (SCC 3.08.030(D)): The exemption from payment of business operations tax granted by this section does not exempt the person conducting the business from complying with any and all other requirements of this code or city ordinances.
