RE: Letter of Understanding- 2024 Successor MOU Extension

Dear Mr. Jamison and Mr. Henry:

This Letter of Understanding (LOU) confirms the agreement reached between the City of Sacramento ("City") and the Sacramento Area Fire Fighters, Local 522 ("Local 522") (collectively, the "Parties") regarding their intent to extend the term of their existing (2023-2024) Memorandum of Understanding (MOU) and provide for a general wage increase. The agreement is as follows:

## <u>1.</u> Term

Section 27.9 of the MOU is hereby amended as follows:

#### 27.9 TERM

- a. This Agreement shall remain in full force from October 1, 2024, through and including October 3, 2025, or until such time as it is superseded by a new Agreement between the parties, whichever occurs later.
- b. The provisions of this Agreement shall be effective on the effective date stated above except as otherwise specifically provided.

### 2. Base Wage Increase

Section 6.1 of the MOU is amended as follows:

### 6.1 2024 SALARIES

Effective November 2, 2024, all salary steps shall be increased by five percent (5%).

# 3. Balance of MOU

The balance of the Parties MOU shall continue unchanged. This constitutes the Parties' complete agreement to amend their MOU.

This agreement memorializes and constitutes the entire understanding between the parties as to all matters referred to or included herein, and supersedes and replaces all prior negotiations, proposed discussion, whether written or oral.
