Introduction

On September 30, 2021, California Governor Gavin Newsom signed into law Bill 481, requiring all California law enforcement agencies to obtain approval prior to the use or acquisition of military equipment from the applicable governing body, by ordinance adopting a military equipment use policy at a regular meeting of the governing body.

The governing body may approve the funding, acquisition, and use of military equipment within its jurisdiction, after a law enforcement agency under its supervision submits a proposed military equipment use policy and makes those documents available on the agency's website at least 30 days prior to any public hearing concerning the military equipment at issue.

The governing body is required to annually review the military equipment use ordinance and determine, based upon an annual military equipment use report ("annual report"), compliance with the standards for approval of each type of military equipment under AB 481.

The annual report must be publicly available on each agency's website and, at a minimum, contain information for the preceding calendar year for each type of military equipment. This information includes:

- (1) A summary of how the military equipment was used and the purpose of its use.
- (2) A summary of any complaints or concerns received concerning the military equipment.
- (3) The results of any internal audits, any information about violations of the military equipment use policy, and any actions taken in response.
- (4) The total annual cost for each type of military equipment, including acquisition, personnel, training, transportation, maintenance, storage, upgrade, and other ongoing costs, and from what source funds will be provided for the military equipment in the calendar year following submission of the annual military equipment report.
- (5) The quantity possessed for each type of military equipment.
- (6) If the law enforcement agency intends to acquire additional military equipment in the next year, the quantity sought for each type of military equipment.

In addition, within 30 days of submitting and publicly releasing an annual military equipment report, the law enforcement agency must hold at least one well-publicized and conveniently located community engagement meeting to discuss and ask questions about the report and the law enforcement agency's funding, acquisition, or use of military equipment.

All details pertaining to Assembly Bill 481 have been codified within Government Code §§ 7070-7075.

Definitions and Categories

Definitions:

Annual costs – The approximate and applicable total of acquisition, personnel, training, transportation, maintenance, storage, upgrade, or other ongoing costs.

Consumable equipment – Equipment that is typically used once, depletes with use, and requires replenishment regularly. Items include, but are not limited to, ammunition, chemical agents, diversionary devices, and other munitions.

Governing body – The elected body that oversees a law enforcement agency or, if there is no elected body that directly oversees the law enforcement agency, the appointed body that oversees a law enforcement agency. In the case of a law enforcement agency of a county, including a sheriff's department or a district attorney's office, "governing body" means the board of supervisors of the county (Government Code § 7070[a]).

Maintenance costs – The cost of routine preventative maintenance, replacement parts, software, licensing, contract fees, and outside vendor services (e.g., labor, parts, and materials). Maintenance completed by employees includes employee salary costs calculated utilizing the average of all employees' pay scales.

Non-consumable equipment – Equipment that may be used repeatedly and for longer periods of time without substantial wear. Typically serialized and requiring periodic maintenance or repair to ensure functionality. Items include, but are not limited to, vehicles, firearms, and less-lethal munition launchers.

Personnel and training costs – The total of an employee's salary incurred during military equipment usage and training. This includes, but is not limited to, course tuition and materials, travel and lodging expenses, certification and licensing, and portions of an employee's salary that is calculated utilizing the average of all employees pay scales.

Reportable use of force (as it pertains to this report) – Reportable use of force that involves any military equipment listed in category 10, 12, or 14.

Reporting period – This report captures inventories, costs, and usage information from May 1, 2023, to April 30, 2024.

Usage – The activation, discharge, detonation, or operation of individual pieces of military equipment utilized on a person or object during an incident.

Categories:

Hereinafter, this report will reference equipment categories that correspond to the definitions of military equipment in accordance with Government Code § 7070(c)(1-15).

1. Unmanned, remotely piloted, powered aerial or ground vehicles.
2. Mine-resistant ambush-protected (MRAP) vehicles or armored personnel carriers. However, police versions of standard consumer vehicles are specifically excluded from this subdivision.
3. High mobility multipurpose wheeled vehicles (HMMWV), commonly referred to as Humvees, two and one-half-ton trucks, five-ton trucks, or wheeled vehicles that have a breaching or entry apparatus attached. However, unarmored all-terrain vehicles (ATVs) and motorized dirt bikes are specifically excluded from this subdivision.
4. Tracked armored vehicles that provide ballistic protection to their occupants and utilize a tracked system instead of wheels for forward motion.

5. Command and control vehicles that are either built or modified to facilitate the operational control and direction of public safety units.
6. Weaponized aircraft, vessels, or vehicles of any kind.
7. Battering rams, slugs, and breaching apparatuses that are explosive in nature. However, items designed to remove a lock, such as bolt cutters, or a handheld ram designed to be operated by one person, are specifically excluded from this subdivision.
8. Firearms of .50 caliber or greater. However, standard issue shotguns are specifically excluded from this subdivision.
9. Ammunition of .50 caliber or greater. However, standard issue shotgun ammunition is specifically excluded from this subdivision.
10. Specialized firearms and ammunition of less than .50 caliber, including assault weapons as defined in Sections 30510 and 30515 of the Penal Code, with the exception of standard issue service weapons and ammunition of less than .50 caliber that are issued to officers, agents, or employees of a law enforcement agency or a state agency.
11. Any firearm or firearm accessory that is designed to launch explosive projectiles.
12. "Flashbang" grenades and explosive breaching tools, "tear gas," and "pepper balls," excluding standard, service-issued handheld pepper spray.
13. Taser Shockwave, microwave weapons, water cannons, and the Long Range Acoustic Device (LRAD).
14. The following projectile launch platforms and their associated munitions: 40mm projectile launchers, "bean bag," rubber bullet, and specialty impact munition (SIM) weapons.
15. Any other equipment as determined by a governing body or a state agency to require additional oversight.
16. Notwithstanding paragraphs (1) through (15), "military equipment" does not include general equipment not designated as prohibited or controlled by the federal Defense Logistics Agency.

Equipment: Inventory, Proposed Acquisitions, and Annual Costs

- Equipment – The manufacturer and model name.
- Initial Costs and Inventory:
 - Procurement – The approximate previous cost, per unit, to procure equipment when initially acquired.
 - Current Inventory – The number of items currently in the department’s inventory.
- 2024-2025 Proposed:
 - Quantity (Qty.) – The number of items the department is proposing to acquire during the next reporting period.
 - Cost per unit – The approximate cost, per unit, to acquire the proposed quantity.
- Annual Costs:
 - Personnel and training cost – The total of an employee’s salary incurred during military equipment usage and training. This includes, but is not limited to, course tuition and materials, travel and lodging expenses, certification and licensing, and portions of an employee’s salary that is calculated utilizing the average of all employees pay scales.
 - Maintenance cost – The cost of routine preventative maintenance, replacement parts, software, licensing, contract fees, and outside vendor services (e.g., labor, parts, and materials).
- Funding Source – The source of funds to include the Police department general fund, grants, or other government funds.

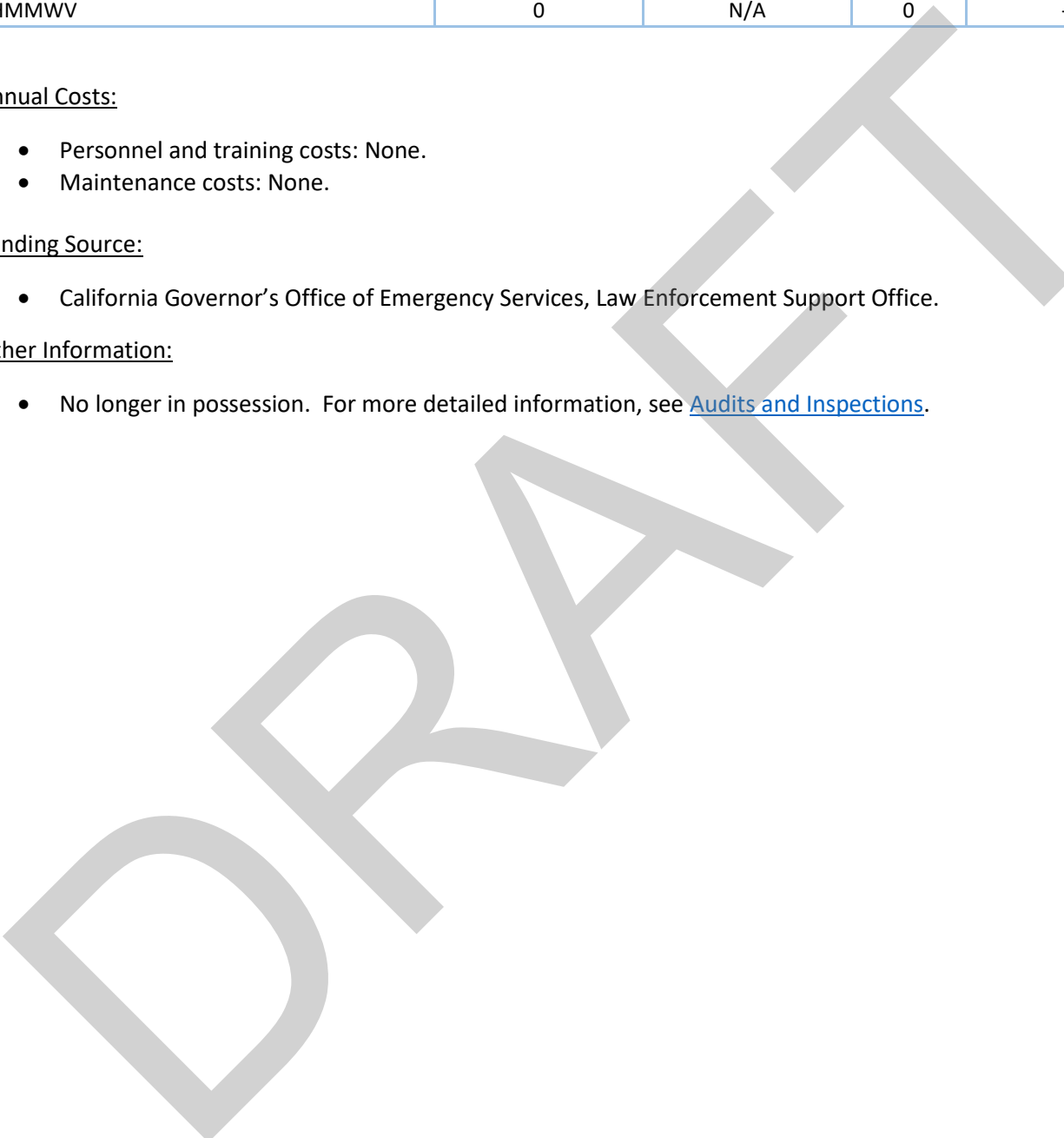

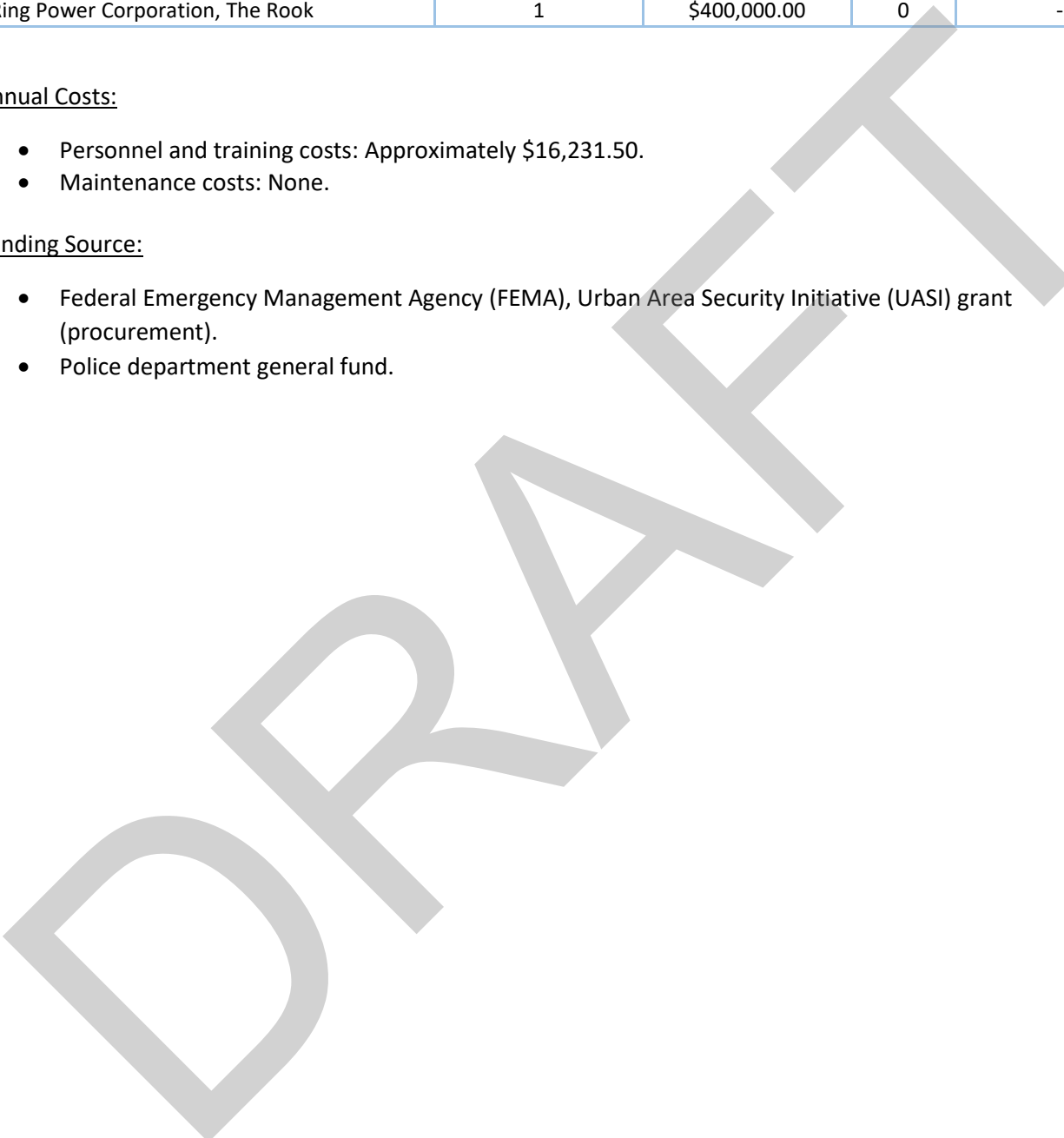

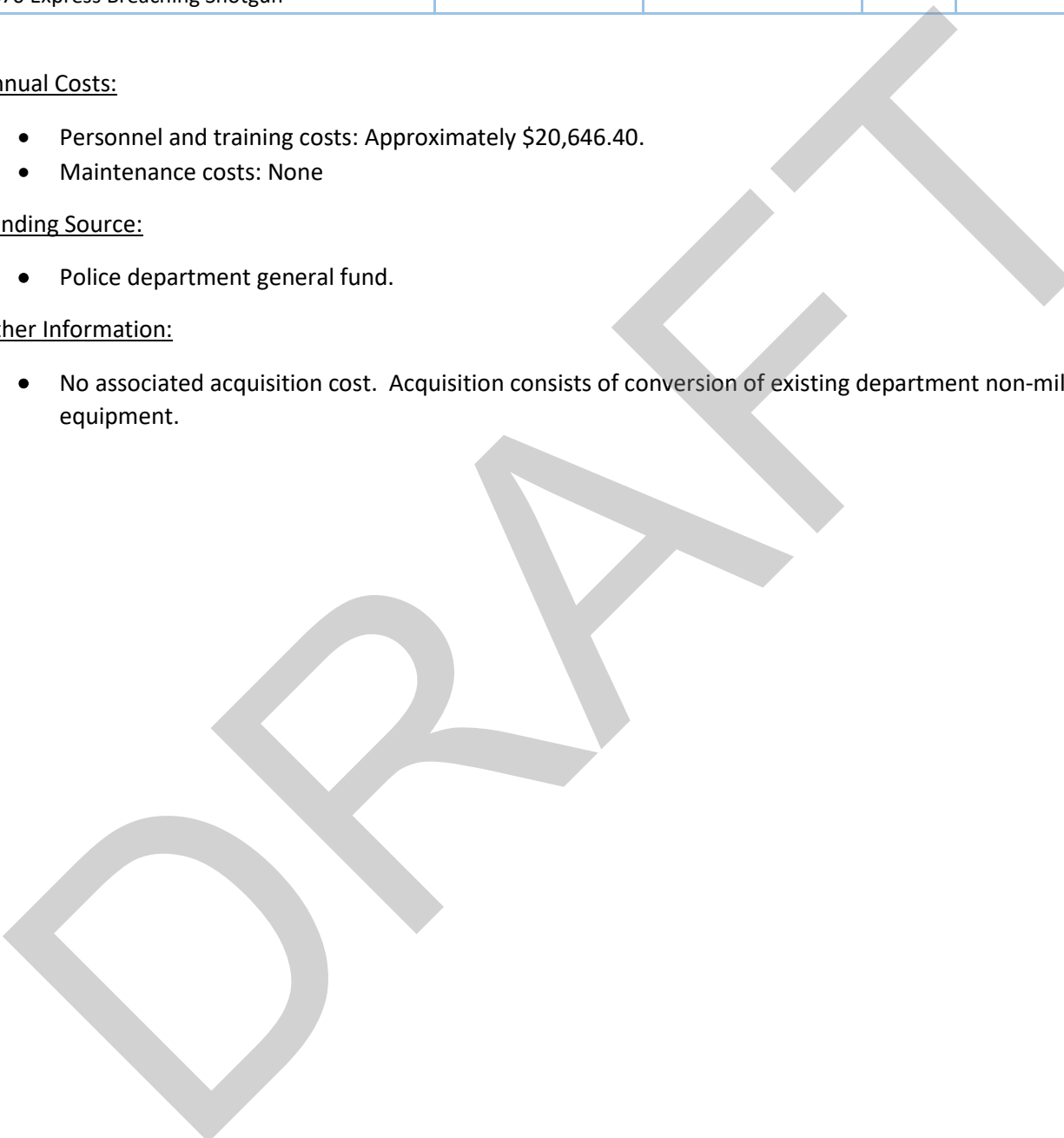

Inspections and Standards Team

The Inspections and Standards Team is comprised of one sergeant, one administrative analyst, one administrative technician, and one reserve officer.

The team's military equipment responsibilities include, but are not limited to, collecting and organizing all department military equipment usage and demographic data, conducting and reporting on regular inspections and audits of the department's military equipment, coordinating procurement information amongst all department offices, and drafting this report.

During this military equipment reporting period, the total salary cost of the Inspection and Standards Team for the department's military equipment inspections, coordination, and reporting was approximately \$142,207.75.

Professional Standards Unit

The Professional Standards Unit is overseen by one captain and comprised of one lieutenant, one sergeant, two officers, two administrative analysts, one administrative technician, and four reserve officers.

The unit's military equipment responsibilities include, but are not limited to, assisting with inspections and audits, verifying all department military equipment usage and demographic data, coordinating with the City Attorney's Office, and drafting the department's military equipment policy.

During this military equipment reporting period, the total salary cost of the Professional Standards Unit for the department's military equipment report assistance, data verification, and policy was approximately \$16,728.86.

Department Armorer

The Department Armorer is assigned to the Evidence and Property Section and is comprised of one senior evidence and property technician.

The armorer's military equipment responsibilities include, but are not limited to, maintaining the inventory of department firearms, ammunition, and munitions, completing repairs of multiple categories of department military equipment, and assisting the Inspections and Standards Team with regular department inspections and audits.

During this military equipment reporting period, the total salary cost of the Department Armorer for the department's military equipment was approximately \$7,170.12.

Use and Reporting

Military Equipment Use

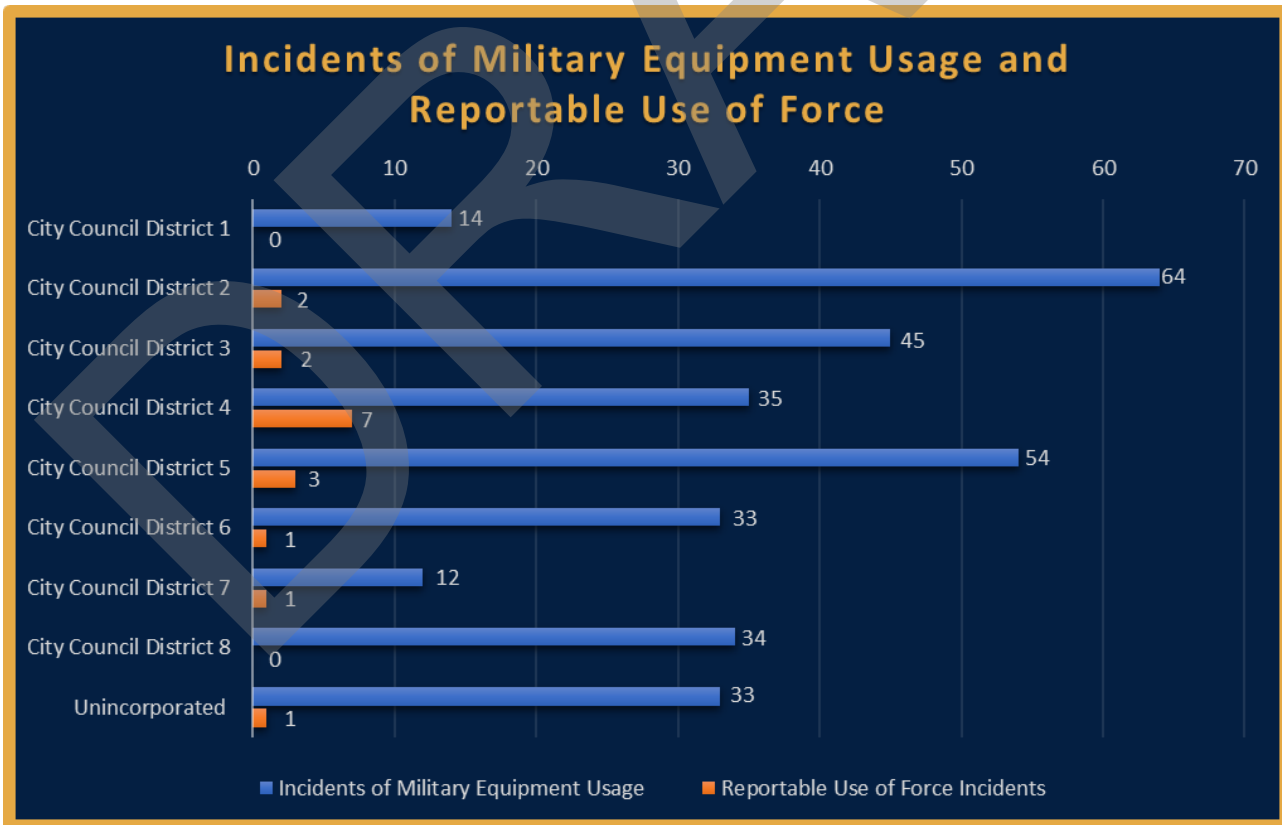
In January 2024, an administrative analyst was hired and assigned to the Inspection and Standards Team solely for the purpose of military equipment reporting. Compared to the last reporting period, the department has widened and refined military equipment usage data collection. For example, consumable items (less lethal munitions and rifle ammunition) and each uncrewed aerial systems device are now individually counted when used during an incident.

The following usage data represents the department military equipment utilized from May 1, 2023, to April 30, 2024. During this period, the department responded to 146,217 calls for service with an officer arriving at the scene and handled 59,320 officer-initiated contacts.

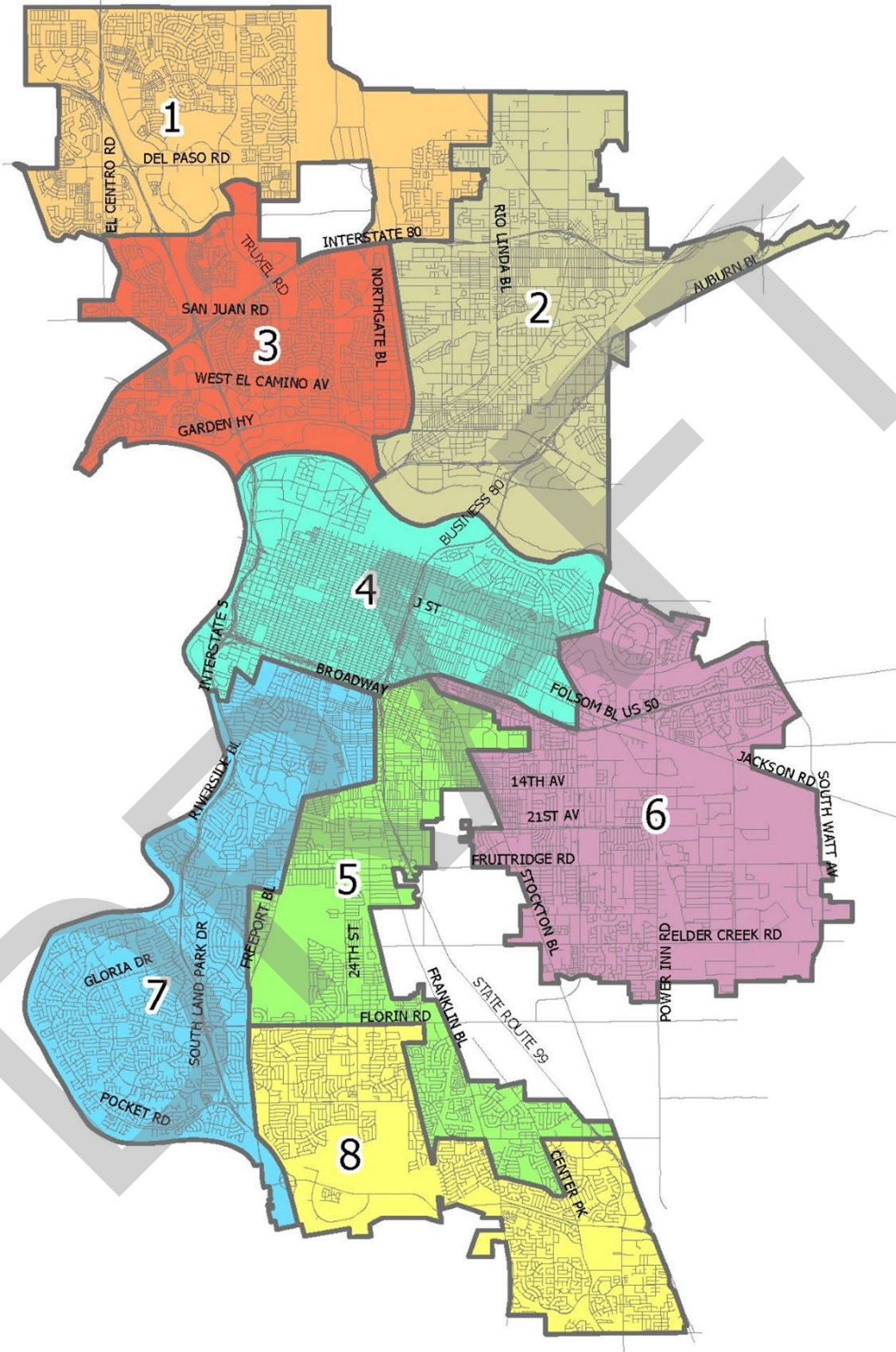
Department military equipment was utilized during 324 incidents, which includes use at multiple locations of the same incident.

During incidents when department military equipment was used to locate, detain, or arrest a person, 210 people were identified by the reporting officer. The count, by race, was Asian (9), Black or African American (111), Hispanic or Latino (49), Middle Eastern or South Asian (3), Pacific Islander (2), White (34), Other (1), and Unknown (1). By gender, male (194) and female (16). By age, 0- to 17-years-old (24), 18- to 24-years old (46), 25- to 34-years-old (62), 35- to 44-years-old (44), 45- to 64-years-old (30), and over 65-years-old (4). Race categories were taken from *California Code of Regulations Title 11 § 999.224*.

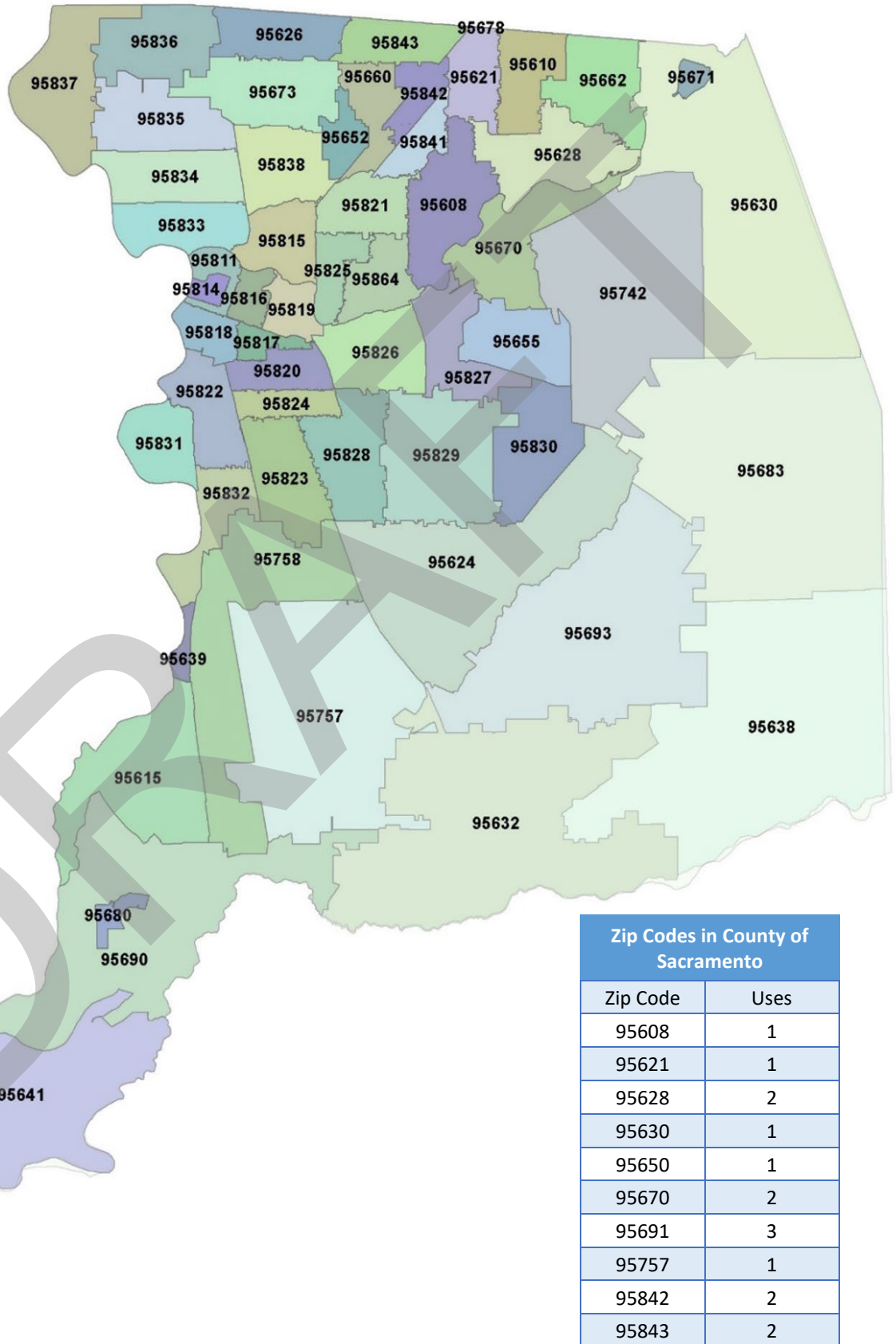
City Council Districts Map

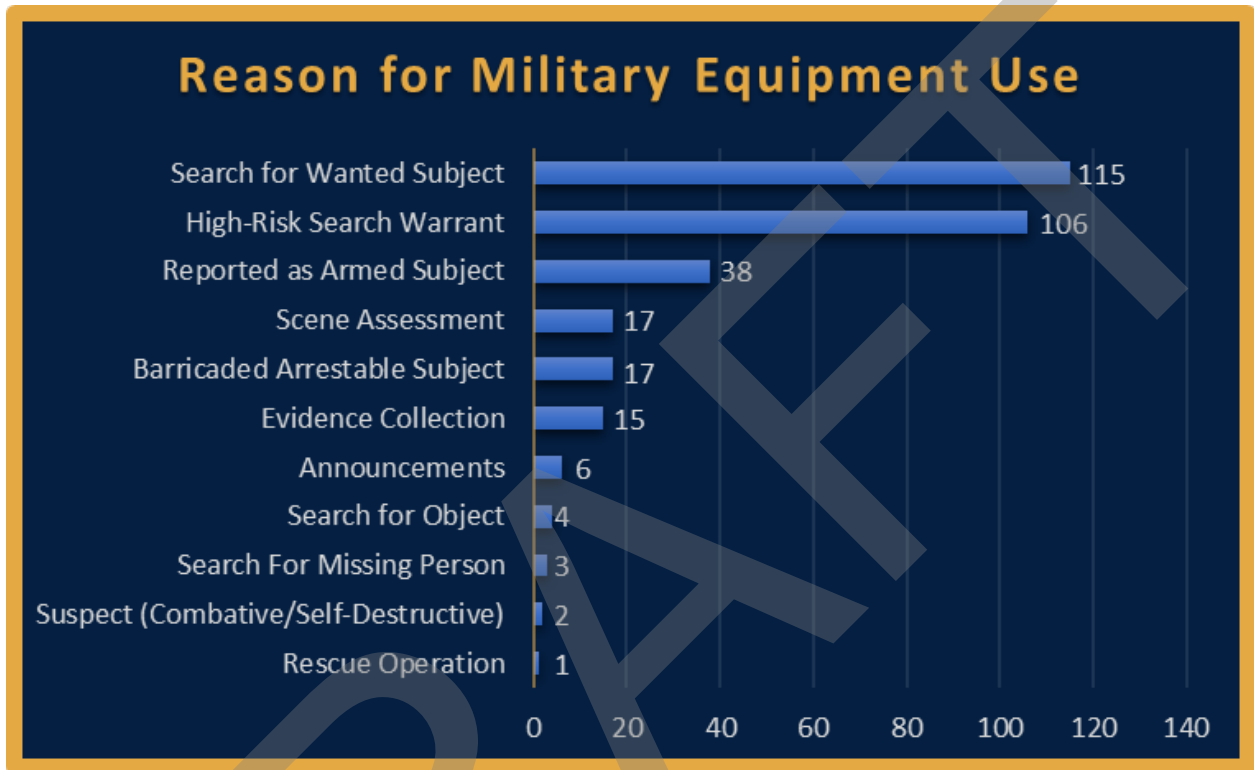

Complaints or Concerns

Internal Affairs Division

The Sacramento Police Department is committed to service, protection, and dedication. Portions of our commitment are focused on accountability, transparency, and trust building through the Internal Affairs Division's employee misconduct investigation process. The division receives, documents, and investigates all complaint allegations of employee misconduct.

Supervisory Staff

Department policy requires every supervisor to receive, document, and report complaint allegations of employee misconduct to the Internal Affairs Division. As such, all complaint allegations pertaining to department military equipment are fully investigated.

Community members may also express concerns related to department policy, procedures, and practices to any supervisor. Department policy also requires every supervisor to receive, document, research and log these concerns as supervisory messages.

The Inspections and Standards Team conducted 12 audits or inspections which include, but are not limited to:

- Inspection of Internal Affairs Division complaints.
- Audit of City of Sacramento, Office of Public Safety and Accountability (OPSA) complaints.
- Audit department computer-aided dispatch, supervisory messages.

Based on the Inspections and Standards Team's completed audits and inspections, the department did not locate any Internal Affairs or Office of Public Safety and Accountability complaints or concerns pertaining to the department's military equipment from May 1, 2023 to April 30, 2024.

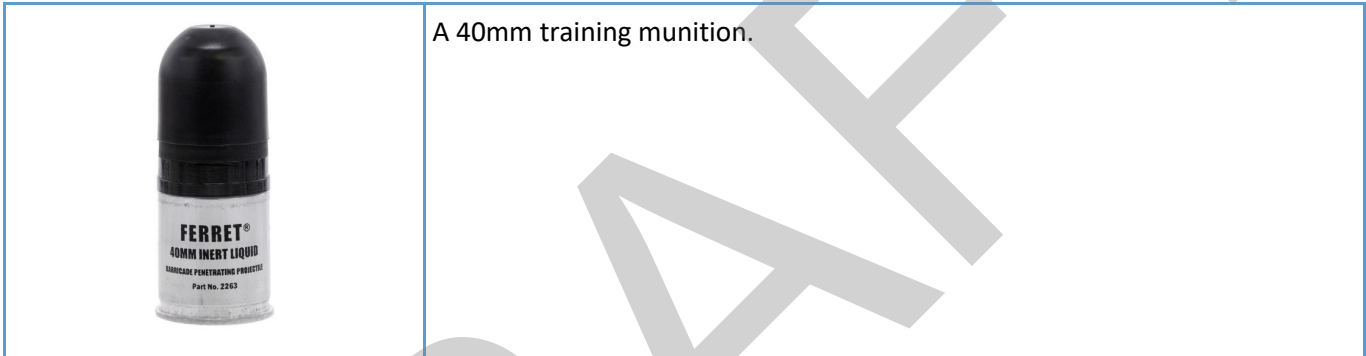

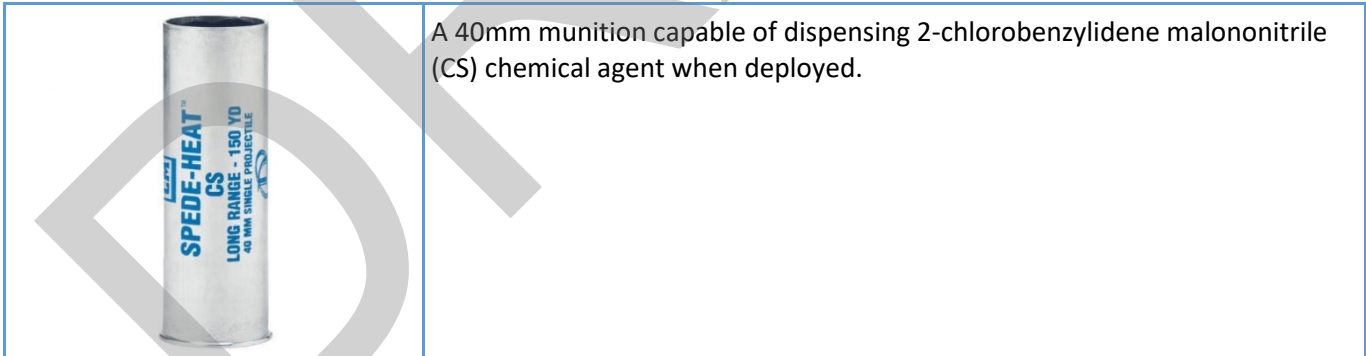

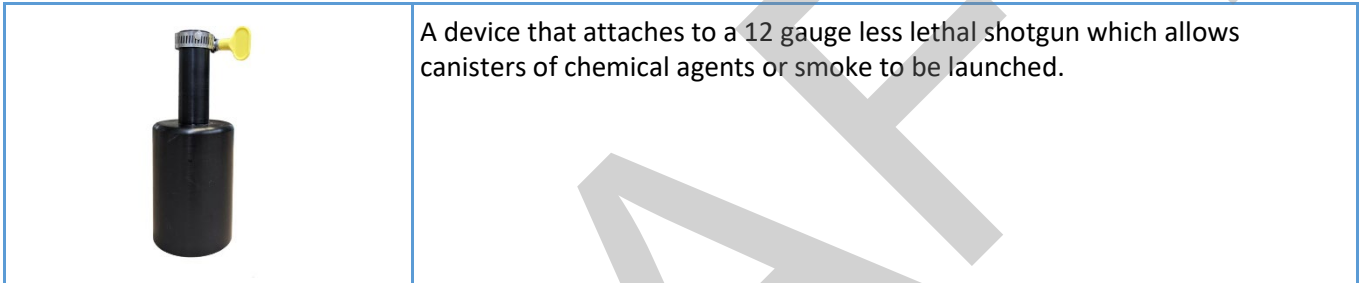

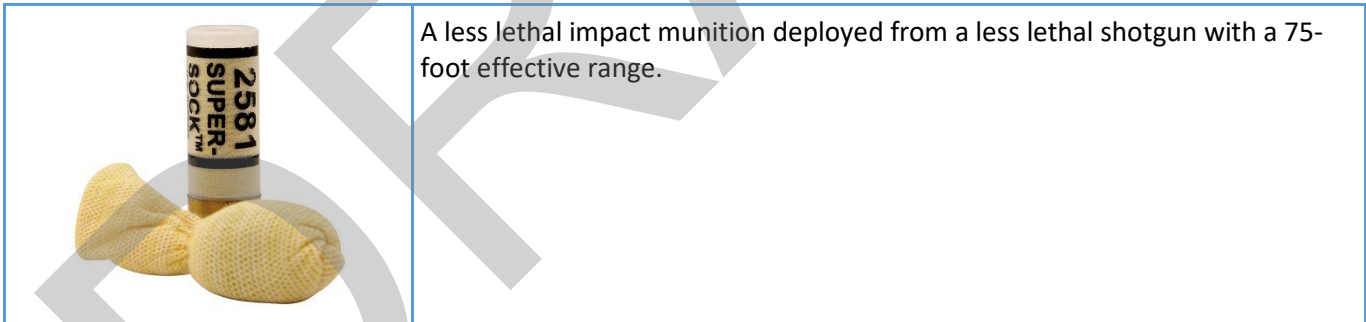

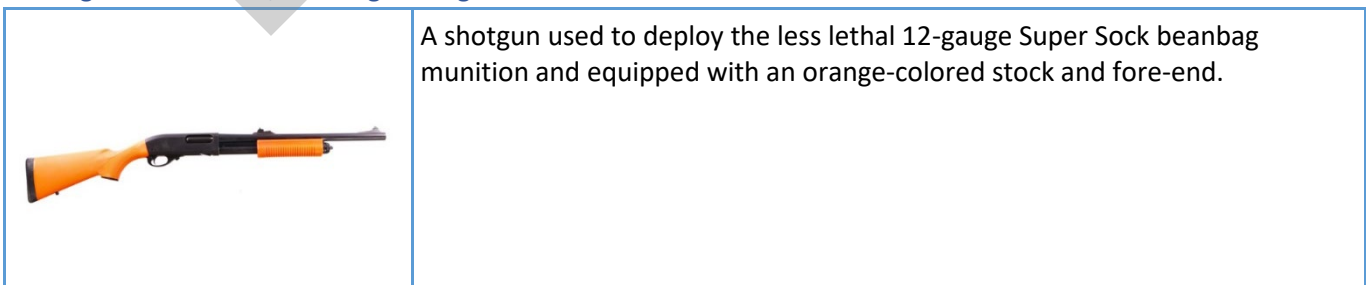
