That's right, in Sacramento you're not "innocent until proven guilty," you're "guilty until proven wealthy." Militarizing police is just the cherry on this particular cake. With 5% of the world's population, the US has 25% of its prisonersfive times the average per-capita incarceration rate. That's seven times the per-capita rates in Canada and France. Soare Canadian and French crime worse than US crime rates? No, actually a little better. One difference is that the US has more than a half million medical bankruptcies annually, while France and Canada don't have those. Could making a half million people more desperate every year lead to crime? Is that really even a reasonable question. Treating people better is a much better solution. Denver gave people experiencing homelessness \$1,000 a month. A year later, nearly half of participants had housing.
