Incident Summary

Officers Fetch and Wolfe were working a security job at the Mix. They were asked by the security at the bar to come inside and assist in separating two individuals out who fighting. They entered the facility and observed security separating the males (one of them being ██████████). They stood by the other male (unidentified) while security took ██████████ down teh elevator and out of the business. Officers escorted the unidentified male out of the bar without issues and he left. Once outside, they observe ██████████ standing in front of security who was telling him to leave ██████████ was very intoxicated: unbalanced, slurring words, bloodshot watery eyes, and a strong odor of alcohol upon his person.

He was refusing to leave and blocking the entrance/exit of the Mix. Officers Fetch and Wolfe went to contact him and ordered him to leave ██████████ pointed his fingers at Ofc. Fetch in a motion that he was going to poke Ofc. Fetch in the chest as he was saying to Ofc. Wolfe, "Who the fuck is your comrade here?" Ofc. Fetch grabbed ██████████ hand before he could touch him in the chest and put him in a rear twist lock. Ofc. Wolfe grabbed his other hand. They walked towards their patrol vehicle with him. At this point they were going to arrest him for 647(f) PC.

Ofc. Wolfe released his hand from ██████████ wrist as he was reaching for his handcuffs. As soon as Ofc. Wolfe was about to plac ██████████ in handcuffs ██████████ tensed out his arm, and turned towards Ofc. Wolfe all while trying to pull his other arm away from Ofc. Fetch. Ofc. Wolfe and Ofc. Fetch, who now believed that due to the pulling away ██████████ was resisting arrest, pulled ██████████ to the ground by his shoulders. When ██████████ fell to the ground, he hit his chin on the gravel, causing a 1/2 inch cut on his chin ██████████ wanted to go with Medics to the hospital for possible stitches to his chin.

CSI photographed the injury, we 849(b)'d ██████████ due to medical treatment needed at the time, and he went with Medics to Sutter General Hospital. Security guards were interviewed, all supporting Ofc. Fetch and Ofc. Wolfes conduct regarding ██████████ and his resistance.

This use of force was within policy.

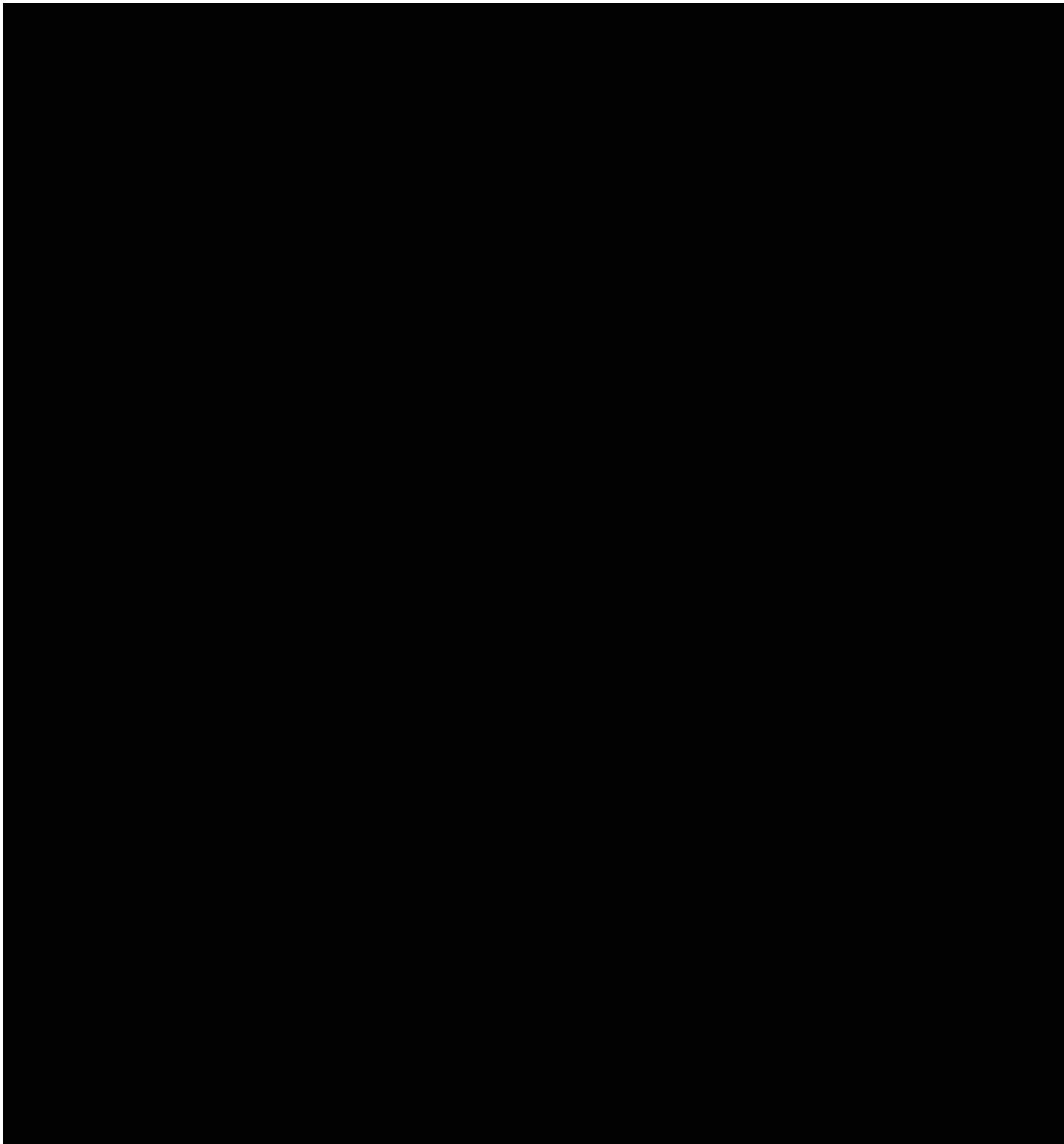

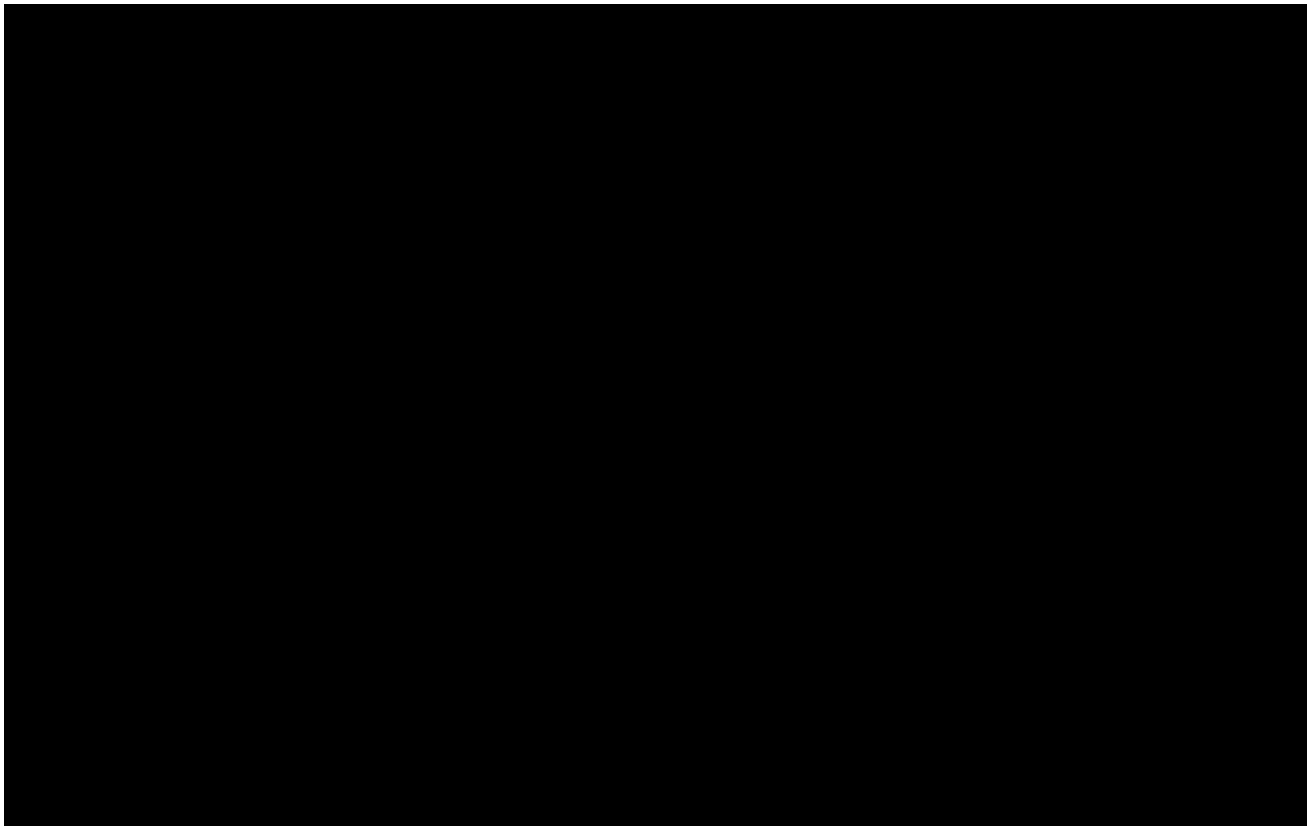

On 3-25-13 at approximately 0130 hours, Officer Wolfe (sct58) and I, Officer Fetch (sct59) were working a security detail at the Mix night club at 1525 L St. We were in full police uniform standing outside of the business in front of our parked marked police vehicles. At this approximate time, we were advised by Mix security that we were needed upstairs by the elevator for a fight. Officer Wolfe and I responded and observed security trying to separate two males from each other. The two males being separated seemed very agitated and appeared to want to fight each other by their body language and facial expressions. The males were trying to push past security to get at each other. Officer Wolfe and I assisted by standing by with one male (unidentified). Security took the other male, later identified as [REDACTED], down the elevator and out of the business. Officer Wolfe and I then escorted the unidentified out of the business and sent him on his way.

Just after Officer Wolfe and I sent the unidentified male on his way, we observed [REDACTED] standing in front of security by the front door. [REDACTED] was standing very close to the security. I could hear the security telling [REDACTED] that he was not welcome and that he needed to leave. [REDACTED] was very intoxicated. He was unbalanced, he was slurring many of his words, his eyes were bloodshot and watery, he had a strong odor of alcohol upon his person, and he had just recently been in an altercation with another patron.

The male was refusing to leave and he was blocking the entrance/exit. Officer Wolfe and I walked up to [REDACTED]. Officer Wolfe told [REDACTED] that he needed to leave by walking away or getting in a cab. [REDACTED] kept asking how he was going to leave. Officer Wolfe explained to [REDACTED] that he could walk away or take a cab, but either way he needed to leave the area. [REDACTED] just stood there in front of the building entrance/exit. I told [REDACTED] that he was not welcome and that he had to leave. [REDACTED] pointed his left index and middle fingers at me and reached out like he was going to poke my chest and said to Officer Wolfe in summary: "Who the fuck is your comrade here". As [REDACTED] was poking at me, I grabbed his left hand just as it reached within an inch or two from making contact with my chest.

placed [REDACTED] in a rear twist lock on his right side. Officer Wolfe and I escorted [REDACTED] across the sidewalk to our patrol vehicle in this position. I was going to place [REDACTED] under arrest for being drunk and disorderly in public, in violation of 647F PC. Officer Wolfe let go of [REDACTED] arm with his right hand and grabbed for a pair of handcuffs. Officer Wolfe maintained a grip of [REDACTED] right wrist with his left hand. Just as Officer Wolfe was going to place the [REDACTED] into handcuffs, [REDACTED] locked out his right arm in Officer Wolfe's direction and turned toward Officer Wolfe. [REDACTED] also tensed up his left arm and tried to pull it from me.

I believed that [REDACTED] was trying to resist arrest by tensing his arms and turning toward Officer Wolfe. I believed there was a high likelihood [REDACTED] was about to become violent with Officer Wolfe and I. As soon and [REDACTED] turned toward Officer Wolfe, Officer Wolfe and I pulled [REDACTED] to the ground. When [REDACTED] fell to the ground, he hit his chin on the gravel. [REDACTED] was then placed into handcuffs without further incident.

[REDACTED] was sat up and I could see that he had blood on his chin. [REDACTED] had a cut on his chin approximately 1/2 inch long. [REDACTED] was sat in the back seat of my patrol vehicle.

I then requested a CSI, a Sgt., additional units, and fire to respond.

Sgt. Ellis responded and was advised of the incident. Officer's Toy, Hawely, and Smith responded and took witness statements. CSI responded to took photographs of [REDACTED] injury.

Fire responded and advised that [REDACTED] may need stitches for his cut. I completed an 849b PC form, gave [REDACTED] his copy, and released him from custody. Fire then transported [REDACTED] to Sutter General hospital.

I work as a "door host" here at The Mix (1525 L St).

Tonight we had two parties kicked out for starting altercations upstairs. I don't know if the altercations were physical or verbal. S1 [REDACTED] was part of the first party to be kicked out. Once he got down stairs he refused to get out of the way of the door way. He was giving our other door host and manager a hard time. Officer Wolfe and the other officer (Officer Fetch) walked over to help mediate the situation.

The officers asked the guy if they could get him a cab. He became more agitated and stated that he lived far away and wasn't going to pay for a cab. The officers told him he needed to "calm down". [REDACTED] grabbed onto Officer Fetch's bicep. Both officers put him into a wrist lock and walked him over to the patrol vehicle (VEH# 10107). While at the car [REDACTED] began trying to resist the officers by pulling his arm away from them. The officers tried to push him up against the patrol car, but it looked like they all fell down. On 03/25/2013, at approx.0130 hours, I Ofc.Wolfe #816 was working a supplemental employment job as uniformed security(SCT58) for The Mix(1525 L St.) During this time I was in full SPD uniform. Ofc.Fetch #273 was also working at this location as uniformed security(SCT59).

Ofc.Fetch and I were standing out front of the establishment when we were advised by the employees who were working the front entrance that they were having issues with a patron upstairs near the elevator. At this time Ofc.Fetch and I ran upstairs to assist the in house security guards(MIX employees) with the patron. As I approached the elevator upstairs I observed a male white adult, later identified as S-██████████, standing in the elevator arguing with the employees. S-██████████ was also yelling at another patron(unknown male black adult) who was standing outside the elevator. The security officers advised that they wanted both subjects escorted off the premise.

At this time the security guards(MIX employees) escorted S-██████████ down stairs using the elevator. Ofc.Fetch and I escorted the unknown male black adult downstairs right after S-██████████ was escorted downstairs. Once we got downstairs we advised the unknown male black adult that he was free to

leave, at which point he left the area with his friends.

As we were sending the unknown male black adult on his way S- [REDACTED] was still arguing with the security guards in front of the front entrance to the establishment. They were asking him to leave and he was refusing to do so. At this time I contacted S- [REDACTED] and advised him that he needed to leave the area. Upon contacting S- [REDACTED] I observed obvious signs of intoxication. S- [REDACTED] had a strong odor of alcohol on his person, slurred speech, and bloodshot watery eyes. S- [REDACTED] refused to leave when I requested he do so. At this time I again advised S- [REDACTED] that he need to leave the area. S- [REDACTED] asked how he was suppose to do that and I suggested a Taxi Cab.

At this time Ofc.Fetch attempted to talk to S- [REDACTED] and advise him that he needed to go home. As Ofc.Fetch was attempting to talk to S- [REDACTED], S- [REDACTED] began to yell, "Who is your fucking comrade", while simultaneously holding his hand up, with his index finger pointed, and stretched it towards Ofc.Fetch's chest in an aggressive manner, coming within an inch of touching him.

At this time Ofc.Fetch grabbed his left arm and put him into a wrist lock, while I grabbed his right arm and put him into a wrist lock. We walked S- [REDACTED] over to Ofc.Fetch's patrol vehicle, which was parked directly in front of the establishment. As we were standing at the rear of the patrol vehicle, still with both of S- [REDACTED] arms in wrist locks, I attempted to grab my handcuffs off of my duty belt. As I released one of my hands from S- [REDACTED] wrist, S- [REDACTED] locked his right arm out towards me and began to push away. As he was pushing away from me he was also pulling away from Ofc.Fetch. At this time Ofc.Fetch grabbed S- [REDACTED] shoulder and we took him down towards the ground. As S- [REDACTED] fell to the ground he hit his chin on the gravel causing a small cut, which began to bleed. Once we had S- [REDACTED] face down on the ground we were able to bring his hands behind his back and place him in handcuffs. We then assisted S- [REDACTED] up off the ground and placed him in the back-seat of the patrol vehicle.

Sgt.Ellis #3018 responded to the scene.
