Please see attached documents and reports.

I, Sgt Porter #3138 (1SM6) arrived at the briefing location and authorized the use of the K9.

I advised over the Radio that I acknowledged the K9 bite.

I arrived on scene of the target location and the scene of the actual K9 bite. I spoke to all the Officers involved including the K9 unit.

After monitoring the Radio traffic, hearing what the Officers told me at the briefing and the scene, viewing the body worn camera video footage, and reviewing the G.O. report, I find that the use of the K9 in this situation was justified and consistent with department policy and training, and was conducted with due regard for public safety.

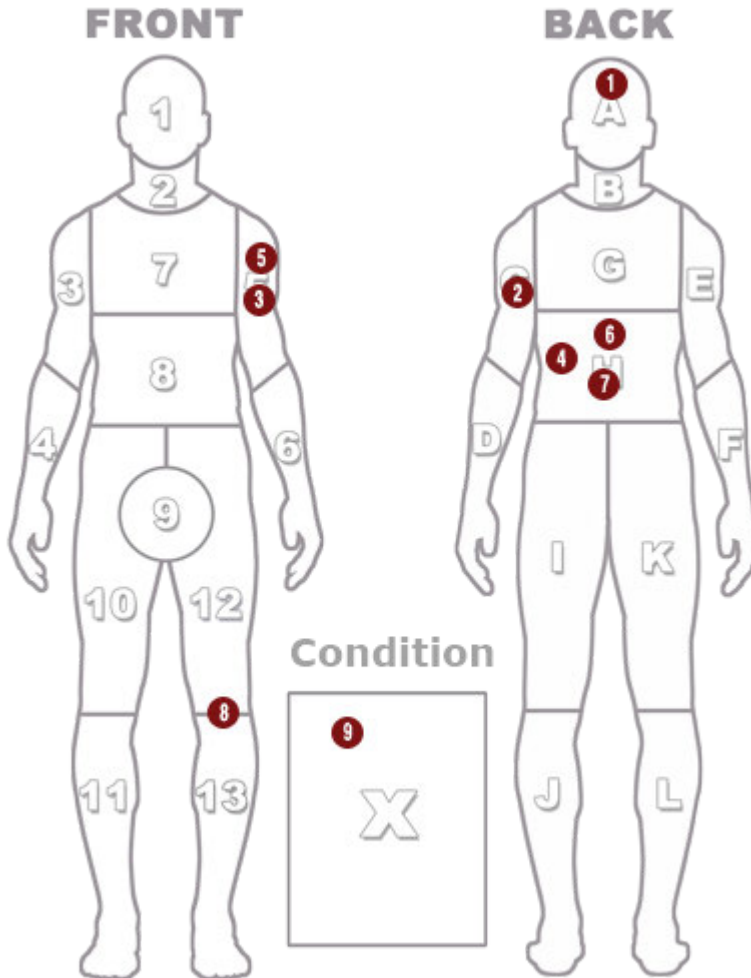

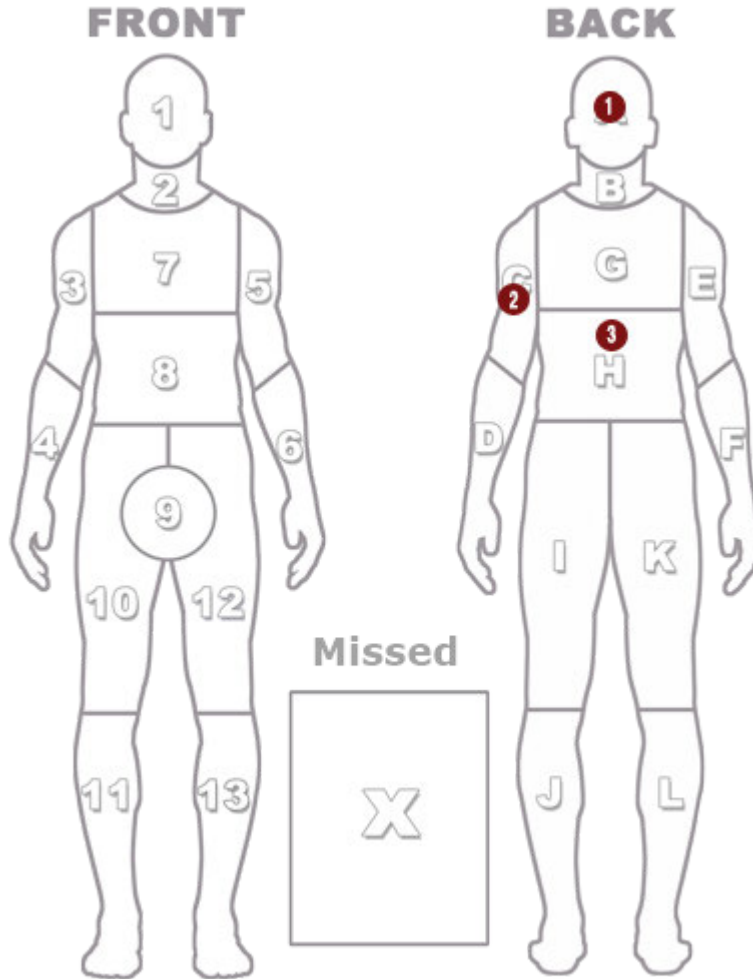

AFFIDAVIT IN SUPPORT OF SEARCH WARRANT OF OFFICER DARBY LANNOM

DARBY LANNOM, your affiant, have been a duly sworn peace officer since 2/18/2000. I initially started my law enforcement career with the Los Angeles County Sheriff's department. I attended an eighteen week POST certified academy. Upon graduation I was assigned to the Airport Courthouse. I worked as a bailiff in a felony trials courtroom. During this time I was able to witness entire trials from beginning to end. I have heard numerous experts testify in the areas of narcotic sales and gangs. In 2001 I was transferred to the Long Beach courthouse where I was assigned to a civil enforcement team. Our team was tasked with enforcing writs of possessions throughout the south bay area. I personally served no fewer than one thousand writ of possessions. On 7/31/02 I left Los Angeles County sheriff's department and took a police officer position with the Sacramento Police department. I was initially assigned to the Office of Investigations in the auto theft unit. My primary responsibility was to investigate auto related crimes. In February of 2002 I transferred to the Office of operations as a uniformed Patrol Officer. During that time, I conducted, as well as participated in, hundreds of preliminary criminal investigations, including but not limited to; murder, rape, robbery, assault, larceny, traffic offenses, and various narcotic related offenses. During the course of these investigations, I conducted interviews with victims, witnesses, and suspects.

Between the dates of February 2002, and January 2004, I was assigned to the Office of Operations, Patrol Division as a uniformed Patrol Officer. During this time, I conducted/ was involved in no fewer than thirty five narcotic investigations including possession for sales, transportation/sales and sales of narcotics and or controlled substance cases.

I have received both my basic, intermediate, and advanced POST (Police Officer Standards and Training) certificates.

Since being employed as a Police Officer, I have personally interviewed several persons for narcotics use, possession, and narcotic dealing. I have spoken to several of these individuals and have become familiar with how controlled substances are manufactured, transported, packaged for sale, hidden, and ingested. I have also become familiar with many of the street

terms used for controlled substances. I responded to numerous locations where I observed illegal activity of possession, selling and using illegal controlled substances and narcotics. I was also involved in observing and seizing different types of paraphernalia and narcotics, including, but not limited to, cocaine (both powder and rock form), methamphetamine, heroin and marijuana. I became familiar with their appearances and means by which they are packaged for use and sales.

I have personally conducted presumptive chemical testing no fewer than 10 times each on the following controlled substances: methamphetamine, rock cocaine, heroin and marijuana. On each occasion, I received a positive reaction for the presence of a controlled substance; my findings were later confirmed by a criminalist at the Sacramento County Crime Laboratory.

In January of 2002, I was assigned to the Sacramento Police Department Problem Oriented Policing Team. This assignment required me to work both in uniform and in plain clothes. During that time, I was involved in the arrests of no fewer than sixty (60) narcotics related offenses. I investigated various crime series and patterns including robberies, burglaries, and narcotics. I personally observed no fewer than twenty (20) subjects under the influence of heroin, methamphetamine, cocaine, marijuana, or alcohol.

In 2004, I attended the Special Investigations Divisions Integrated Narcotics Training (INT) Course for patrol officers. This course was forty (40) hours of instruction. I was instructed in basic narcotics investigations by investigators and prosecuting attorneys who have many years of experience in the areas of narcotics, vice, gambling, and abatement enforcement. This course of instruction included, but was not limited to, the methods of packaging, distributing and sales of controlled substances/narcotics, clandestine labs, undercover procedures, search warrant preparation, surveillance techniques, vice/gambling operations and search and seizure

I am currently a member in good standing with the California Narcotics Officers Association (CNOA). In November of 2003, I attended a forty (40) hour CNOA conference on the subjects of undercover safety, undercover operations, and search warrant services.

Statement of Probable Cause

On May 15, 2019 at approximately 0004 hours Sacramento Police Officers responded to [REDACTED] Villa Juares Circle in Sacramento CA to attempt to arrest a subject named Billie Chao. At the time Billy Chao had a felony warrant for 25850(A) PC (carrying a loaded firearm in a public place). Chao was also currently on Formal searchable probation to [REDACTED] Villa Juares Circle in Sacramento CA.

Officers arrived and made contact at the residence. They contacted the following subjects at the residence:

[REDACTED] a stated friend of Bille Chao
[REDACTED] stated to be Billie Chao's girlfriend
[REDACTED] s three year old son
[REDACTED]
[REDACTED]

Officers conducted a protective sweep of the residence. During the sweep of the residence Officer Leonard stated that he saw multiple gun cases and ammunition boxes in the back (northeast) bedroom closet. Officer Leonard stated that he later determined that the back bedroom was Chao's parents' room [REDACTED] and [REDACTED]. The parents [REDACTED] and [REDACTED] were not home at the time that officers were at the residence. Officers ran records checks on [REDACTED] and [REDACTED]. Neither subject could be located in our system as being on probation of parole. Officers did not search the bedroom further.

While officers were making contacts with the occupants in the residence Billie Chao fled out of a bathroom window. He was apprehended by officers that were surrounding the area. Officers conducted a search of Billie Chao shortly after he was arrested. Officers located the following items on his person.

Officers conducted a probation search of Billie Chao's bedroom. No illegal items were located in his bedroom. Officers conducted a search of an adjacent garage in the garage they located the following:

Box of .22 caliber ammunition located next right next to the garage door.

Directly below the box of ammunition officer located a black backpack. The large pocket was open and inside the officers located the following:

Smith and Wesson .40 caliber handgun with a silver frame and black grip serial number [REDACTED]

14 round silver smith and Wesson magazine loaded with 12 live .40 caliber rounds (this was located inside the handgun.

Two- 10 round H&K .40 caliber magazines both loaded with 10 .40 caliber live rounds

Black unknown capacity extended magazine with 16 live .45 caliber rounds inside

Box of .40 caliber ammunition that contained 67 live rounds

A single .45 caliber live round.

I know based upon my training and experience and the experience of other officers that magazines are predominately brand specific. If you have a Smith and Wesson magazine you would need a Smith and Wesson capable magazine to be able to fire the handgun. Based upon this knowledge the two H&K .40 caliber magazines would not fit in the Smith and Wesson handgun that was located in the backpack.

Officers ran a records check on the handgun located in the backpack. There was no dealer record of sale for the firearm. The occupants of the residences were questioned about the handgun locating in the garage. No one claimed ownership of the handgun.

When Billie Chao was questioned about the firearm, he denied ownership of the handgun and said that the only one that could own the handgun would be his cousin [REDACTED]

[REDACTED] was questioned. He stated that he had been staying at the residence for a few days because he got kicked out of his residence. [REDACTED] said that Billy Chao was his cousin and [REDACTED] is his uncle. [REDACTED] denied knowledge or ownership of the firearm located in the garage.

Officers spoke to Billie Chao's sister [REDACTED]. [REDACTED] told officers that her parents own the house and that her father has guns for hunting, but they are locked up in

a cabinet. [REDACTED] stated that she only knew her father to have long guns like a shotgun and rifle for hunting. I ran records check on [REDACTED] I did not locate any firearms currently registered to [REDACTED]

I know based upon my training and experience and the experience of other officers that often times subjects that are subjected to fourth amendment waivers will go to great length to prevent officers from located illegal items in their possession. It is common for these subjects to place illegal items in rooms, and locations of other subjects to prevent law enforcement from locating them.

I ran a criminal history check on Billie Chao. Billie Chao has a Felony conviction for a violation of 25850 (A) PC- carrying a loaded firearm (Case [REDACTED]). Billie Chao was sentenced to 90 days in county jail and was placed on five years of formal searchable probation on November 21, 2018. One of the conditions of his probation is that he is not allowed to possess firearms or ammunition.

California penal code section 29815 states the following:

Any person who, as an express condition of probation, is prohibited or restricted from owning, possessing, controlling, receiving, or purchasing a firearm and who owns, purchases, receives, or has in possession or under custody or control, any firearm, but who is not subject to Section 29805 or subdivision (a) of Section 29800, is guilty of a public offense, which shall be punishable by imprisonment in a county jail not exceeding one year or in the state prison, by a fine not exceeding one thousand dollars (\$1,000), or by both that imprisonment and fine.

I know based upon my training and experience that subjects that possess firearms will often times keep other firearm related items at their residences. It is common for gun owners to have holsters, storage boxes, ammunition, cleaning kits and other indicia at their residences.

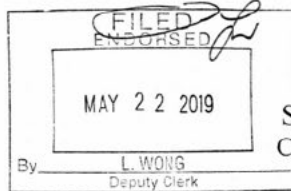

On Wednesday, 5/15/19, at approximately 0330 hours, I (Officer Rodarte #967) took a Mirandized statement (Miranda rights previously read by Officer Jensen) from Billie Chao (identity confirmed via county Webkpf records/photo) while at the UC Davis Medical Center Emergency room, regarding a resisting arrest incident. The statement was recorded on my body worn camera. Chao stated the following in summary:

I was in my room sleeping, and heard you guys knocking. I knew I had the warrant, and got scared, so I ran out the back. I jumped out the bathroom window, and over the back fence. I heard the Officer yelling to stop, but I needed to get away. I messed up, I know I shouldn't have run.

I got kicked out of this house last year for getting caught with a gun. I just moved back here, and have no idea whose gun you found. I had no idea it was in the house or who could own it. The only person I can think would have a gun in the house, is my cousin ([REDACTED] [REDACTED] but I do not know.

I was pulled over with family members who run with [REDACTED], but I was never affiliated with them.

The cell phone I had is not mine, but my girlfriend's ([REDACTED]), so I do not have the pass code.

On Wednesday, 5/15/19, at approximately 0230 hours Officers Powers #1037, O'Shaughnessy #1043, Leonard #877, Jensen #935, Nishimura #504, Thomson (K9) #364, Henderson (K9 with partner Ike) #343, and I (Officer Rodarte #967) responded to [REDACTED] Villa Juarez Cir, to serve a felony arrest warrant on suspect Billie Chao, and to conduct a probation search of his residence. The operation was recorded on body worn cameras. I observed the following in summary:

Prior to our arrival, I conducted a records check for Billie Chao (identity confirmed via county Webkpf records/photo) which confirmed the following active felony no bail warrant:

- Warrant No: [REDACTED], Docket: [REDACTED], Judge: BOWMAN, MICHAEL, Issued: 03/13/2019, Charges: 1203.2(B)PC - Probation Violation, 25850(A)PC - Felon in possession of Firearm.

The records check also confirmed Chao to be on Formal searchable Probation for 25850(A)PC- Carrying of a loaded firearm. (DK: [REDACTED])

The records check showed Chao to be associated with the Asian gang [REDACTED], although Chao later denied affiliation.

Upon arrival, Officers Thomson, Henderson, and his K9 partner Ike set up to the rear of the residence at [REDACTED] Casa Del Este Way. The rest of us made contact at the front of the home.

Upon contact, [REDACTED] [REDACTED] (identity confirmed via county Webkpf records/photo) let us inside the house. It should be noted that [REDACTED] had a misdemeanor warrant for 25400(A)(3)PC- vehicle occupant concealing a firearm. (WNO: [REDACTED])

As Officers began to clear the interior of the residence, I contacted Chao's girlfriend ([REDACTED] - ID confirmed using DMV records/photo) and three year old son ([REDACTED]) in the first bedroom to the left of the living room, nearest to the garage.

An adult Asian female ([REDACTED]) and a juvenile girl ([REDACTED]) were located in a bedroom to the right of the living room.

While speaking to [REDACTED] in her bedroom, I heard someone in the rear bathroom. Officers were advised that a subject had escaped out the rear bathroom window, ran to the back fence of the residence, and jumped over into [REDACTED] Casa Del Este Way. Officer Henderson, and his K9 partner Ike, positively identified the subject running, as Billie Chao, gave commands to stop, and subsequently detained him. (see Officer's observations)

Officers conducted a search of Chao, incident to arrest, and located \$1,128 dollars in his shorts pocket, a California Drivers License, a blue Amazon bank card, and an Alcatel cell phone (cracked screen). All but the cell phone were later booked with Chao at the Sacramento County Jail.

Engine and Medic 10 arrived on scene to provide Chao Medical Aid.

Officers Jensen and Nishimura conducted a canvas of the area with negative results for witnesses or cameras.

Officer O'Shaughnessy and I conducted a probation search of Chao's bedroom. Officer O'Shaughnessy continued his search in the adjacent garage. In the garage O'Shaughnessy located a Smith and Wesson handgun, along with loaded magazines, and ammunition inside a back pack hanging on the wall, to the right of the door. Officer O'Shaughnessy seized the handgun, and later booked the backpack and all of its contents at Sequoia Pacific booking center.(see Officer's supplement)

I sent a request for the handgun, magazines, and ammunition to be processed for DNA and prints.

From my training and experience I know that individuals involved in gang activity will often take pictures of themselves holding firearms, drugs, and money. I seized the cell phone found on Chao, and sent a request for the digital forensics unit to process the phone. I later booked the cell phone at the Sequoia Pacific booking center.

Medic 10 transported Chao to the UC Davis Medical Center Emergency room. Officer Jensen rode in the ambulance with Chao. While on the way, Officer Jensen read Chao his Miranda rights verbatim from his SPD 133 card. Chao replied yes to each right read, indicating he understood his rights.

I later took a Mirandized statement from Chao at the UC Davis Medical Center emergency room. (see suspect statement)

I, Officer Lannom am currently assigned to the Sacramento Police Departments street gang investigations team. My primary duties are to investigate gang related crimes in and around the city of Sacramento. On the above date and time, I was teamed with Officer Catricala. Both Officer Catricala and I were both wearing full police uniforms, that included duty belts and black vests that clearly stated "Police" on the front and rear. Both officers were equipped with body worn cameras. We were driving a black Police SUV equipped with numerous forward facing red and blue lights, as well as a siren. The vehicle is also equipped with a in car camera system.

Below is a summary of the event. By no means is it an exact account of the incident. Some of the details may be out of chronological order or summarized. By no means is the following report meant to be a verbatim account of the incident. Please see the body worn camera and/or in camera footage for exact details. On 5-17-2019 I became aware of a arrest of Billie Chao that occurred on 5-15-2019. During that contact the officers located a back pack that contained a firearm, and several magazines, as well as ammunition. I ran a records check on Billie Chao. The most current listed address given by Billie Chao to probation was [REDACTED] Villa Jaures Circle in Sacramento CA. I ran a DMV check on Billie Chao. On 10-27-2017 Billie Chao listed [REDACTED] Villa Jaures circle to be his current address. On 5-17-19 when Officers went to [REDACTED] Villa Jaures circle Bille Chao, his girlfriend [REDACTED], and his child were at the residence. Based upon the above information it appears that Billie Chao lives at [REDACTED] Villa Juares circle.

On 5-21-2019 I obtained a search warrant for [REDACTED] Villa Juares circle, and any vehicles that are associated with the residence. I held a briefing regarding the search warrant service at the location. The following subjects were at the briefing: Officers, Catricala, [REDACTED] [REDACTED] K9 Officer Pinola, and Sgt. Faria. I assigned Officer Catricala to act as the "finder" of evidence at the location. When we arrived Officer [REDACTED] and I went to the front door of the residence. I knocked on the front door. After a few knocks a female subject who was later identified as [REDACTED] opened the front door but left the outer security screen door closed. I told [REDACTED] that officers were there to conduct a search of the residence and that we had a search warrant. [REDACTED] told Officers that she didn't live at the residence and didn't feel comfortable opening the door. I showed [REDACTED] a copy of the search warrant and told her that she needed to open the door. She still refused and began to walk back into the residence.

Officer [REDACTED] pulled the front screen door open. I detained [REDACTED] in handcuffs. Officers gave commands for any other occupants to come to the front door. A subject who was later identified as [REDACTED] came to the door carrying [REDACTED]'s three year old son [REDACTED]. I knew from reading the original police report that [REDACTED] has an active warrant for possession of a firearm. He was detained in handcuffs. Officers cleared the rest of the residence. In clearing the residence officers had to force three interior doors open, causing damage to the jambs.

Once the scene was secured I removed the handcuffs from [REDACTED] so she could care for her son. A search of the residence was conducted. See officer Catricala's observations for further details. During the search numerous firearms were located. There was a handgun and several long guns in the closet of what is believed to be a room that belongs to Billie Chao's parents. In the garage officers located a handgun, shotgun, rifle, and ammunition. I

ran records checks on all the firearms. Of all the guns located in the south bedroom only the Benilli shotgun was registered. The Benilli came back registered to [REDACTED].

I ran a records check on Billie Chao. Chao has a past conviction for 25850(A) PC ([REDACTED]). On 11-21-2018 Billie Chao was sentenced to 90 days in county jail and placed on five years of formal searchable probation. One of the conditions of his probation is not to own or posses firearms or ammunition. Based upon the items located in the residence it is clear that Billie Chao has knowledge and access to the firearms that were located at his address. [REDACTED] told me that she has been staying at [REDACTED] Villa Juares Circle with her boyfriend [REDACTED] and their child [REDACTED]. [REDACTED] said that she dose not live at the residence but she has been staying there visiting.

During a phone call I listed to that Chao made to telephone number [REDACTED] on 5/21/2019 at 1952 hours Chao would speak in English for the majority of the call, but at times would switch to Mien and speak to who I believe to be his girlfriend [REDACTED]. During this call Billie Chao learns that officers served a search warrant his residence. At approx. 1:50 into the [REDACTED] tells Chao that the house got raided and [REDACTED] [REDACTED] got arrested on his warrant. [REDACTED] told Chao that the officers seized nineteen items. When Chao asks what kind of items [REDACTED] tells him "All your dads (unknown word in Mien) and stuff. I had Officer Saechao translate [REDACTED]'s words and he said that she said gun in Mien.

At 2:01 Chao says a long statement in Mien. According to Officer Saechao Chao asked [REDACTED] if [REDACTED] put the stuff away yesterday. [REDACTED] responded in Mien that he dint hide it well enough so they found it. Knowing the facts of the case it is my opinion that after Chao was arrested from his residence located at [REDACTED] Villa Jaures circle he and [REDACTED] [REDACTED] had an understanding that he was suppose to hide Chao's firearms at his house in order to prevent their discovery. Based upon this call it is my opinion that Chao has knowledge and possession of the firearms located at his residence.

At approximately 0216 hours, I arrived on scene. I took up a position inside of the rear yard of [REDACTED] Casa Del Este Way which is just south of the warrant service residence.

At approximately 0236 hours, contact officers at the front advised that they were contacting someone at the front door. At 0238 hours, officers advised over the radio that they had a few people detained in the residence but were still looking for (S) Chao.

Shortly after that radio traffic, I heard the sounds of movement and what sounded like someone running through the rear yard of the target location. I then heard the fence being hit and I observed a dark figure jumping over the fence into the yard I was positioned in. As the person jumped over the fence I turned on my flashlight pointing it at the figure. I confirmed it appeared to be (S) Billie Chao. I immediately yelled, "Police K9! Get on the ground!". He landed on the ground and immediately started running southwest through the backyard.

At this point, I deployed my police service K9 "Ike" to apprehend (S) Chao based on the following facts known to me at that time:

- 1) (S) Chao was wanted on a felony gun possession warrant.
- 2) (S) Chao was actively resisting arrest by attempting to flee from identified police officers in violation of 148(A)(1) PC.
- 3) (S) Chao had not been searched for any weapons and it was unknown if he was armed with anything that could be utilized against officers attempting to effect his arrest.
- 4) He was fleeing inside of a residential neighborhood and posed a possible threat to nearby citizens if not immediately captured.
- 5) As soon as he jumped over the fence he showed no hesitation or any indication to surrender after my K9 announcement, instead he continued running at a sprint through the yard.

K9 "Ike" after being instructed to apprehend (S) Chao pursued him southwest through the yard. He caught (S) Chao and initially apprehended him on his upper back near the west fence-line of the backyard. The impact caused (S) Chao to fall to the ground onto his stomach and caused K9 "Ike" to

momentarily release his hold of him.

Officer Thomson and I ran over to where K9 "Ike" and (S) Chao were. I observed that K9 "Ike" now had (S) Chao by his left upper arm. We instructed (S) Chao to show us his hands and not to move. He complied and I took positive control of K9 "Ike". I gave him an out command and he immediately released and I put him at a heel.

Officer Thomson was then able to safely place handcuffs on (S) Chao without further incident. I requested Sacramento Medic/Fire units to the scene to treat the suspects injuries.

Additional officers responded to our location to assist with custody.

(S) Chao was walked out to the Casa Del Este Way and I observed that he had the following injuries:

- 1) Punctures and lacerations to his back.

Sacramento Fire Department and Medic unit 10 responded to the scene. They provided medical treatment to (S) Chao. They transported him to U.C. Davis medical center.

Officers conducted a neighborhood canvas and checked for any possible witnesses. A CSI call was made up for photographs of the suspects injuries.

Sgt. Porter responded to my location and I debriefed him on the details of the apprehension.

I contacted Officer Rodarte and advised him to attempt to gain a statement under Miranda from (S) Chao.

My body worn camera was activated during the entire event. Officer Thomson also advised that his body worn camera was activated during the incident.
