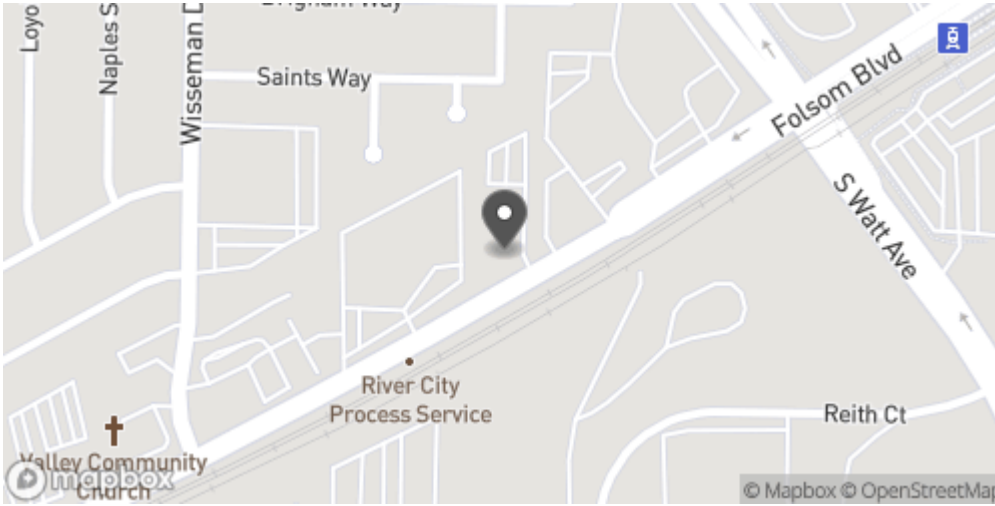

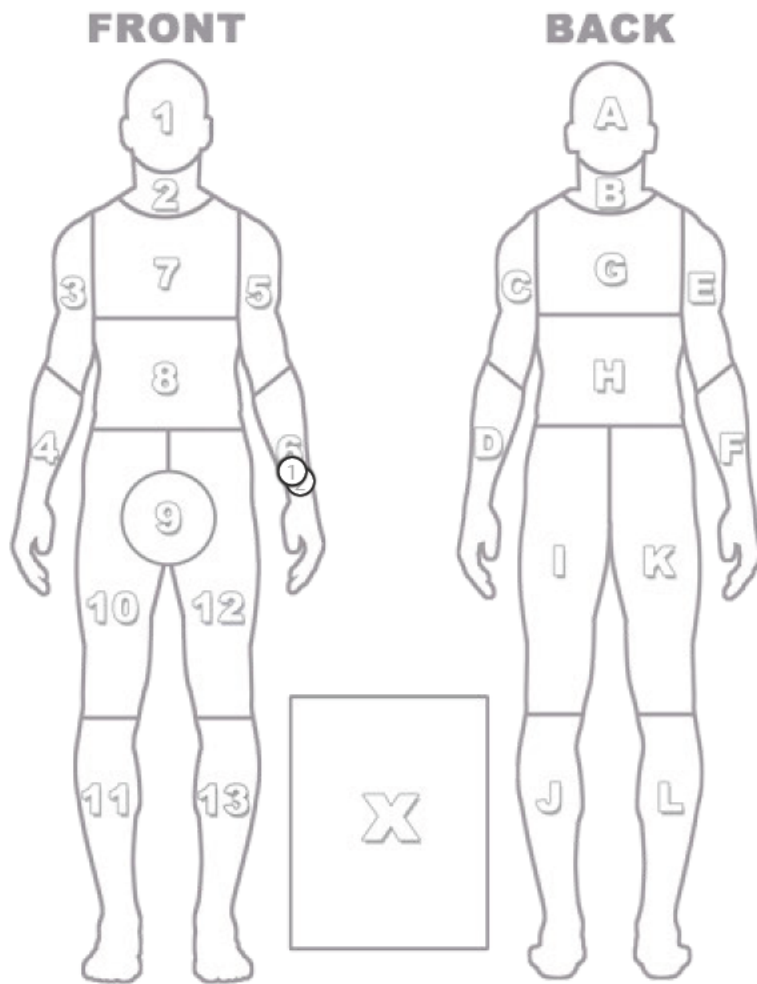

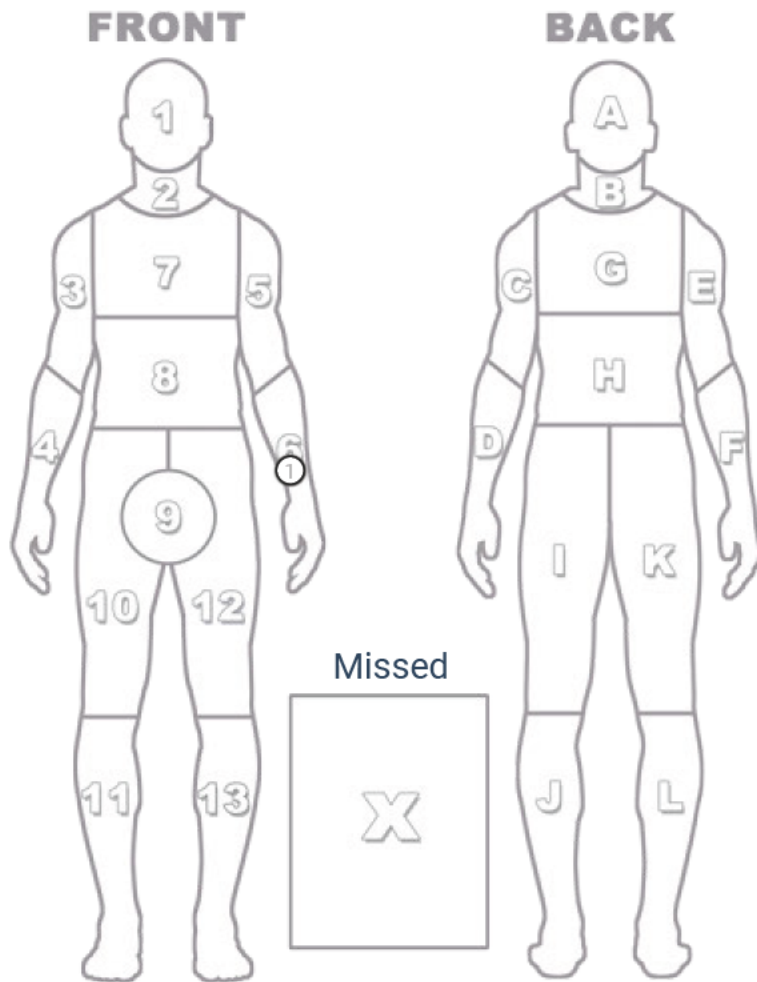

On 03/02/2023 at approx. 0951 hours, I (Ofc. Pancoast #924) was en route to 8181 Cucamonga Ave, Sacramento, CA regarding a stolen vehicle that was mapping at this address. Per the text of the call, the complainant stated a SPD Detective's take home vehicle (Ford Fusion ■■■ LIC# ■■■■■■■■) was stolen and mapping at this address. The vehicle was stolen out of Roseville, CA (RPD rpt# 2023-10765). I arrived on scene at approx. 1001 hours. I was wearing full SPD uniform and driving a fully marked SPD patrol vehicle. Officers were on scene prior to my arrival.

Prior to my arrival, K93 (Ofc. Prahls #698) voiced over the radio that there were two subjects at the hood of the vehicle and appeared to be working. K96 (Ofc. Terman #879) then voiced that one male was running westbound and the other one was at gunpoint. K93 advised that his dog was in pursuit, and had a bite on suspect. A short time after that, the suspect was in custody. Ofc. Steadman #420 was on scene with K93. (See Ofc. Prahls's supplement)

Upon my arrival, Officers were providing medical aid to S-James Alsbury due to his dog bite. Ofc. Virk then transported S-Alsbury to where Sacramento Fire Department was staging so they could provide further medical aid. S-Alsbury was transported by SFD to UC Davis Medical Center (UCD), Ofc. Hernandez #714 responded to UCD. Ofc. Hernandez contacted S-Alsbury and obtained his statement. (See suspect statement)

I contacted S-William Frear in the backseat of Ofc. Moua's #628 patrol vehicle, and obtained his statement. (See suspect statement)

On Thursday, March 2, 2023 at approximately 0938 hours I, Officer Stedman #420, was dispatched to 8181 Cucamonga Ave (Granite Regional Park) for a stolen vehicle. As I got closer, I could see that the silver vehicle was indeed the stolen Ford Fusion, and what I had originally perceived to be the trunk of the vehicle, was actually the hood of the vehicle, and the two subjects were in the engine compartment. As I was approaching, the subject on the driver's side of the stolen vehicle began to run towards the rear of the vehicle. At this time, I used my Public Address System (PA) and provided two separate K9 warnings, identifying myself as a Police K9 Officer, and advising both subjects that if they ran, they would be bitten by a police K9. This did not deter the suspect on the driver's side of the vehicle and he continued to flee. The suspect briefly paused at the open driver's door of the stolen vehicle and I was unable to tell if he deposited something into the vehicle or retrieved something from it before continuing his flight.

After the brief pause at the open driver's door, the suspect (later identified as James Alsbury-Suspect) fled westbound over an embankment and down the levee into an open field. I continued past the stolen vehicle in my own patrol vehicle for a distance of approx. 20 to 30 yards before stopping. I exited my patrol vehicle and surveyed the general area for any civilians or other personnel and did not see any other people in the general area except for S-Alsbury still fleeing Westbound through the open field. I provided S-Alsbury with one final verbal K9 warning, advising him that if he continued to flee, he would be bitten by a police K9. At this time, S-Alsbury was approx. 100 yards away and still fleeing Westbound. I retrieved my Police K9 "Groc" from the rear of my patrol vehicle and commanded him to apprehend S-Alsbury based off of the following criteria:

- S-Alsbury was in constructive possession of a recently stolen unmarked police vehicle when I arrived on scene, and it was my perception that he was a suspect in the theft of said vehicle.
- S-Alsbury fled the scene prior to being searched for weapons.
- S-Alsbury fled, after being given a lawful order to surrender, including K9 warnings, in violation of 148 PC.

Based off of my training and experience, I know that criminals steal vehicles in order to go undetected while committing other more serious crimes in which they are often armed with weapons capable of causing serious bodily injury or death.

- S-Alsbury temporarily halted his flight to go into the driver's compartment of the vehicle and I was unsure if he had done this to retrieve a weapon.
- S-Alsbury was fleeing towards an area of heavy woods/vegetation. Such an area is dangerous for officers to search based off of a suspect having a plethora of locations to hide and potentially ambush officers as they are searching.
- I knew that by using a police K9, it would greatly enhance my own safety and further limit S-Alsbury's ability to flee.

K9 "Groc" pursued S-Alsbury into a creek and up the opposite embankment, where K9 "Groc" made contact with S-Alsbury, apprehending him on the left forearm. As I closed the distance between myself and S-Alsbury, I could see K9 "Groc" apprehending S-Alsbury by the left forearm; and S-Alsbury was still trying to climb a chain link fence into a sports field, but K9 "Groc" was preventing him from doing so.

As I approached S-Alsbury, I gave him commands to show me both of his hands, and he complied. I then commanded S-Alsbury to get on the ground. After several commands to get on the ground, S-Alsbury did comply and laid on the ground face down. At that time I moved forward and gained positive control of K9 "Groc" and I advised S-Alsbury that I was going to remove K9 "Groc" from his arm, and if he attempted to run again, he would be bitten again. I then commanded K9 "Groc" to release S-Alsbury, and he did.

A short time after K9 "Groc" released S-Alsbury, Ofc. Stedman #420 arrived with me and took positive control of S-Alsbury and placed him in handcuffs. While S-Alsbury was being taken into custody, he made the following spontaneous statement:

- I'm sorry, I have warrants and I know it and I'm sorry. I was given every opportunity to surrender and I apologize.

After S-Alsbury was apprehended by K9 "Groc", fire personnel were requested over the radio to care for S-Alsbury's wounds. S-Alsbury was walked back to where my patrol vehicle was parked and I assessed his wounds and found that there was no excessive bleeding that required immediate attention and he was transported to the opening of the park where fire personnel were waiting to provide follow up care.

S-Alsbury was transported to the UC Davis Medical Center (UCDMC) Emergency Room for further care. I responded to the UCDMC and contacted S-Alsbury and obtained a statement from him (see supplemental suspect statement for further details). I also further observed S-Alsbury's injuries to be multiple puncture wounds to his left forearm consistent with injuries incurred from a K9 apprehension. I was also advised that S-Alsbury had sustained a fracture to his left forearm as a result of the K9 apprehension.

CSI was requested to take photographs of S-Alsbury's injuries.

I contacted the second individual (William Frear-Suspect) that was at the hood of the stolen vehicle and I obtained his statement (See supplemental suspect statement for further details).

On 3/2/2023 I, Officer Hernandez #714 made contact with James Alsbury at the UC Davis Medical Center. ALSBURY was in custody and receiving medical care. I read ALSBURY his rights per Miranda (verbatim via SPD 133). ALSBURY verbally stated he understood each right and waived his rights. My body worn camera was on and activated. ALSBURY stated the following in summary:

I don't live here. I came here to see my friend "██████". I don't know his real name. He's mixed race in his late 20's. I don't know if he lives here. He wanted to use my phone so I let him borrow it. I didn't have my phone for about 4-5 hrs. About 1-2 hours after sunrise, I noticed that there was a Ford Fusion similar to my fiance's. It's currently broken down because it needs a battery.

I had been walking by the car, left and came back, and even asked people around whose it was. I figured it was just ditched here. No, I didn't think it was stolen. I just really needed the battery. There was a guy, tall, skinny, in his 40's, non white, that was also near the car. I think he was sawing something off of it I'm not sure.

I asked him if he knew whose car it was and he said he didn't. I asked him if I could have the battery. He told me that he was planning on taking it, but that I could.

I was trying to take it but wasn't able to take it. I heard the engines of cars driving fast and the dust so I figured it was the police. I ran because I knew I had a warrant. My probation officer had told me I had a warrant.

I don't remember what I heard. I remember hearing some sort of yelling but I couldn't make it out. Then the dog bit me. I should have never ran.

The car that I need the battery for is also a Ford Fusion. It's my fiance's - I don't know what year it is. Her name is, ██████████ (██████████) [xref:██████████]. She has the car right now. It's not registered to me. It might be registered to her. The car is broken down somewhere in Carmichael near Eastern.

It's been about 24hrs since I've seen my fiance's car. I usually stay there.

I popped the hood, checked under the passenger's seat and the driver's seat for a jack, well I did check the trunk too. Hell no, there wouldn't be prints on the steering wheel. I didn't even sit in the car. I can assure you that my DNA wouldn't be in any other place.
