Additional Description/Analysis

Issue Detail: This report serves as an informational update to the City Council on the City's climate action progress for late 2023. City staff have advanced the development of key policy documents, onboarded new staff, and successfully competed for additional state and federal investment from highly competitive grant programs. In total, staff received notice of over \$11 million in climate-related grant award recommendations in the fourth quarter of 2023.

In 2024, City staff are advancing several foundational policy documents that will further strengthen the City's long-term commitments to climate change and help operationalize the City's efforts to prepare residents and neighborhoods for climate impacts. Upcoming policy milestones in 2024 include:

- 2040 General Plan and Climate Action & Adaptation Plan (CAAP): Recommended adoption of the revised draft, scheduled for City Council action on February 27, 2023.
- Draft Urban Forest Plan and Parks Plan 2040: Public release anticipated in the first quarter of calendar year 2024.
- Existing Building Electrification Strategy: Recommended adoption of the revised draft in the

spring, completing a priority early action item from the Climate Implementation Work Plan.

These documents build on years of planning and community engagement. Collectively, the plans will serve as a robust foundation for achieving the City's commitment to carbon neutrality, as well as implementing an equitable approach to climate adaptation.

The Office of Climate Action & Sustainability also on-boarded two new team members to augment City efforts and build capacity for community engagement on climate issues. Staff include two limitedterm positions: a Civic Spark Fellow, and an Arts Assistant with California Creative Corps funding secured and facilitated by the City's Office of Arts and Culture.

A summary of additional climate accomplishments in late 2023 is available in Attachment 2, Status of Climate Tasks. The list in Attachment 2 includes the City's priority, early action climate efforts that were established in the 2021 Climate Implementation Work Plan (Work Plan). Following adoption of the CAAP, staff will update the Work Plan to reflect the next phase of priorities, staff capacity, and available resources.

Policy Considerations: The City of Sacramento is committed to achieving carbon neutrality by 2045 (Resolution No. 2019-0433). The City's Climate Emergency Declaration advances the City's commitment to "maximum feasible efforts to implement emergency-speed carbon reduction actions towards eliminating emissions by 2030 as much as possible" (Resolution No. 2019-0465). The progress outlined in this report demonstrates the City's ongoing commitment and progress towards these goals.

Economic Impacts: While this report has no direct economic impacts, the achievements summarized in this report illustrate the economic co-benefits and opportunities from the City's climate initiatives. The City's climate actions support ongoing competitiveness for state and federal funding. By attaining limited grant funds that increasingly prioritize climate-oriented approaches, the City has secured significant state and federal investment that advance local sustainability goals while supporting the local creative sector, funding local nonprofits, and providing resources for vulnerable and low-income homeowners.

Environmental Considerations: This report does not constitute a "project" as defined by Sections 15061(b)(3) and 15378(b)(4) of the California Environmental Quality Act (CEQA) Guidelines.

Sustainability: As outlined in this report, City staff are advancing climate action as a priority. Staff have secured funding to improve active transportation, plan for climate impacts on transportation infrastructure and transit, mitigate flood risks, and invest in communities with community forestry and resiliency initiatives. The long-term planning efforts underway will ensure a continued commitment to enhancing Sacramento's sustainability and resiliency in a changing climate.

Commission/Committee Action: On November 29, 2023, City staff presented proposed revisions to the draft 2040 General Plan and CAAP to the Planning and Design Commission. Planning Commissioners indicated their support for proposed changes, including land use changes that will increase floor area ratios and support overall reductions in vehicle miles traveled.

Rationale for Recommendation: These quarterly updates to the City Council help to establish transparency and accountability for the City's climate action progress. The intent of these reports is to further strengthen the City's sustainability commitments.

Financial Considerations: One-time funding in the Climate Action Initiatives Program (I15240100) is supporting several near-term climate action priorities. This funding is also providing a portion of local cost share for competitive grants.

The City's implementation of climate-oriented activities helps to ensure the City's continued competitiveness for state and federal dollars, where climate is increasingly prioritized for highly competitive grant programs. Utilizing staff dedicated to sustainability issues as well as on-call consultant support, City staff were able to submit numerous grant applications in 2023. In total, climate-related grant award recommendations announced in late 2023 exceed \$11 million.

Local Business Enterprise (LBE): Not applicable.

Background: Securing external funding to implement the City's climate work remains a critical task. Recent awards will improve the City's flood resilience, advance adaptation planning, accelerate community tree plantings, and increase neighborhood resilience. Staff have successfully partnered to secure funding from an array of state and federal partners, to take advantage of limited term augmentations for new and existing grant programs. Note that staff are working to finalize agreements for these funds, to initiate implementation in 2024.

In the fourth quarter of 2023, climate-related grant award recommendations announced for the City exceed \$11 million. Recommended awards include:

- **\$1.5 million from the Caltrans Sustainable Transportation Planning Grant Program** for vision zero planning for Howe Avenue, complete streets planning for Norwood Avenue, and a transportation infrastructure adaptation plan in partnership with SacRT.
- Over \$7.7 million from the Caltrans Transportation Commission Local Transportation Climate Adaptation Program to improve 24 floodgates around the city to protect climate vulnerable communities, including over 300,000 people and 240 critical facilities.
- **\$1 million from the USDA Urban & Community Forestry Grant Program** to expand the urban forest and support community engagement and stewardship.

• **\$1 million from the US EPA Environmental Justice Government-to-Government Program** for neighborhood resiliency, community engagement, water conservation, tree plantings, and school greenings.

2022 - 2023 Tasks

This table summarizes priority tasks for the Office of Climate Action and Sustainability (OCAS), and other department leads. Staff presented this list to the City Council in early 2022 as an update to the 2021 Climate Implementation Work Plan.
