

# **CEMETERY BURIAL REQUEST PROCESS**

To request a burial at the Sacramento Old City Cemetery, please follow the steps below. Plots are all sold and only members of families may be buried in Cemetery. No new burial plots are available.

1. Contact Cemetery Manager staff at (916) 808-4070 or by email to

cemetery@cityofsacramento.org to set up an appointment to discuss burial request.

- 2. Complete all application forms.
- 3. Provide proof of relationship to family ownership of plot (ie: deed to plot, death certificate of family member already buried and show how related to deceased, etc).
- 4. Additional forms required at time of burial:
  - a. Application and Permit for Disposition of Human Remains
  - b. Death Certificate
- 5. Burial Fees to be paid at time of burial.

# <u>Burial</u>

Includes; identifying and coordination of grave site preparation\*, escorting funeral and family members, securing the burial plot upon completion of service, and filing of appropriate documents for official records.

Check Payable to City of Sacramento:

Weekday burials: \$450.00 Saturday and Sunday burials: \$600.00 Administrative fee: \$50.00

\*Additional fees are required for contracted ground excavation payable to contractors.

Fee for excavation of burial site: Between \$2,000-\$3,000 depending on site preparation needed.

Rental of Lowering Device: \$600

# **Cremation Burial**

Includes; identifying and preparing grave site, escorting funeral and family members, digging cremation plot, securing the burial plot upon completion of service, and filing appropriate documents for official records.
